The WSRF # 2018-818 was paired with two other CWCB grant agreements (CMS#111864 CTGG1 2019-275 and POGG1 2020-3028) throughout the grant period. WSRF 2018-818 expires today (April 30, 2021) while the other agreements continue through January 31, 2023. Those items marked as not yet complete will be completed through the previously referenced grant agreements.

Completion of Tasks in the Scope of Work:

TASK 1: Engaging Stakeholders

Subtask 1.1 Advisory Committee (a.k.a. Stakeholder Group)

The Stakeholder Group met on April 8th, 2021. During that meeting the Colorado Water Trust (CWT) presented on the various streamflow restoration tools and water transactions used throughout the state of Colorado. Meeting participants discussed the information from the CWT presentation and explored how the various services that CWT offers could support ERCWP efforts.
