Task 4 – Post-Training Technical and Coordinative Assistance to ag groups; Completed.

On-going communications with ag producers, as well as conservation districts, state agencies, consultants, and others. Types of assistance provided have included meeting and event planning and coordination, presentations, articles for local publications, and individual consultation. Topics on which assistance has been provided include irrigation efficiency and conservation, demand management, drought contingency planning, water right abandonment, watershed and stream management planning, wildfire impacts and mitigation, water quality, return flows, and grant funding for water projects.

Task 5 – Collaboration and Communications; Completed.

Collaborative Communications and/or virtual meetings with agricultural organizations (state and local), ag-affiliated state and federal governmental agencies, non-profit funders, and agricultural organizations have played a key role in helping conservation districts, producers, irrigation companies, individual irrigators, and others make advancement toward solving agricultural water and multi-benefit challenges.

Task 6 – CCA Staff, Completed

CCA Staff devoted time and resources to help on all tasks, listed and detailed above.

Project Summary:

The Ag Water NetWORK engaged producers on watershed and stream management via outreach as well as other ag water-related topics using a tailored approach that strove to meet producers and conservation districts at their level of informational need. Outreach activities included collaboration with other ag organizations (CAWA, Colorado State Conservation Board, individual conservation districts, RMFU, Colorado Corn, CLA, others) and focused on elevating understanding about WMPs and SMPs among ag producers and organizations &

individuals that work with ag producers and raising awareness regarding other ag water topics of interest.

All of these activities were designed to advance producer understanding and engagement on local water management planning efforts and inform ag and non-ag entities and groups about the water-related priorities and perspectives of Colorado agriculturalists.

We relied on local ag groups to initiate and help coordinate the workshop and some meetings. This approach resulted in productive and well-attended meetings and ensured topics addressed local interests. The challenges associated with COVID-19 prevented us from accomplishing three of the four workshops, but we were able to produce additional publications and webinars to make up for the lost workshops.

Overall, the 2020 project activities represented a foundation-building and informational dispersion growth period and helped advance engagement with the agricultural water community on watershed, stream, and integrated water management planning, as well as other ag water topics. We worked closely with the Colorado Ag Water Alliance (CAWA) and several other organizations. The feedback from both ag groups has been quite positive. Meetings occurred both virtually and in person when and where allowed.

A total of \$80,500 match funding has been provided by CCA in the form of cash match and inkind contributions to the project.
