ORDER GRANTING JOINT MOTION REQUESTING EXTENSION OF PREHEARING DEADLINE

THIS MATTER comes before the Hearing Officer on the joint motion of the Staff of the Colorado Water Conservation Board ("CWCB Staff"), Colorado Parks and Wildlife ("CPW"), and the Southwestern Water Conservation District ("SWCD") (collectively, "Parties", to extend the deadline for the Parties to provide prehearing statements. The Hearing Officer, having reviewed the motion and being otherwise adequately advised, enters the following order:

Rule 5c of the Rules Concerning the Colorado Instream Flow and Natural Lake Level Program, 2 CCR 408-2 ("ISF Rules"), states that "[w]hen necessary, the Board may modify or delay this schedule [for contested instream flow appropriations] or any part thereof as it deems appropriate." Moreover, Rule 5n states that the Hearing Officer shall assist the Parties in "adjusting deadlines and schedules to further the Parties' settlement efforts or for good cause shown." Rules 5n(2) and 5n(5) also allow additional information to be submitted by the parties past the deadline of five working days before the prehearing conference, "for good cause shown or as agreed upon by the Parties." Moreover, Rule 5n states that the Hearing Officer shall assist the Parties in "adjusting deadlines and schedules to further the Parties' settlement efforts or for good cause shown."

The Hearing Officer finds that good cause exists, and the case will be best served if the deadline for prehearing statements is continued. The motion is GRANTED, and the following deadline in this matter is revised as follows:

Monday, July 19, 2021 at 12:00 noon; Prehearing Statements Due

The date of the prehearing conference and the deadline for rebuttal prehearing statements remain the same, so that the relevant dates are as follows:

- a. Deadline for Prehearing Statements: July 19, 2021 at 12:00 noon
- b. Prehearing Conference: July 19, 2021 at 4:00 pm
- c. Deadline for Rebuttal Prehearing Statement: August 16, 2021

d. Hearing Date: September 15-16, 2021
