Background:

For this agenda item, the Board is provided with a brief overview of applications to the Water Supply Reserve Fund (WSRF). Attachments to this memo include:

- Summary spreadsheet detailing funding requests for the basin and statewide accounts;
- Summary spreadsheet displaying current WSRF Balance Summary of Fund Appropriations and Receipts by Fiscal Year, and Fund Distribution by Basin and Statewide Account.
- Water Activity Summary Sheets, which provide an overview, discussion, issues/additional needs, and staff recommendation regarding funding, partial funding, or not funding the applications.

Staff's review of the applications involves the following steps:

- 1) Applications are reviewed for completeness based on the information requirements, which are primarily outlined in the Criteria and Guidelines (C&G).
- 2) Applications are reviewed to verify that the water activity meets the eligibility requirements in Section 39-29-108 (III) C.R.S. (C&G, Part 2) and the threshold criteria, which are based on the requirements of Section 39-29-108 (III) C.R.S., and two sections of the Water for the 21st Century Act (House Bill 1177); Section 37-75-102 and Section 37-75-104(2)(c) (C&G, Part 3). Staff also verifies that the applicant was an eligible entity to receive funding (C&G, Part 2).



3) Staff then prepares the Water Activity Summary Sheet which documents the outcome of the review process and contains staff's recommendations.

Staff recommends approval of up to \$25,000 from the Metro Basin Account, up to \$25,000 from the South Platte Basin Account and up to \$75,000 from the Statewide Account to help fund the project: Aquifer Storage Recovery Modeling Assessment

Water Activity Summary: If approved, the applicant will use WSRF funds to conduct a Aquifer Storage Recovery (ASR) modeling assessment to sustain groundwater levels in the currently mined Arapahoe Aquifer and thereby maintain long-term well yields. Under this conjunctive management strategy, in wet years, renewable surface waters from the South Platte would be diverted, conveyed through East Cherry Creek Valley's Northern Pipeline (an existing IPP in the South Platte Basin Implementation Plan), treated, and injected into the Arapahoe Aquifer. The water would be recovered during dry years, with the goal of establishing a balance between the quantities recharged and the quantities pumped, stabilizing long term groundwater conditions.

This project entails the development of a groundwater modeling tool to simulate the Arapahoe Aquifer behavior in relation to ASR injection and extraction schedules to further investigate the feasibility of how well ASR may achieve sustainable groundwater conditions underlying the applicant's service area which would aid in sustaining groundwater levels

outside of their service area. Funds from the WSRF will be used to develop the model, evaluate scenarios and document results.

The applicant plans to use the results of this modeling investigation to inform future ASR implementation and system management. A report documenting modeling results will also be made available to Colorado water providers pursuing ASR to inform the technical development of this relatively new water storage strategy within the State.

Discussion: This proposal meets the Water Plan of reducing the Municipal & Industrial gap in the basin as well as meeting South Platte Basin Implementation Plan's goals of promoting multi-purpose storage projects; maximizing implementation of IPP's; maximizing use of existing South Platte water supplies including groundwater; and managing the risks of climate change.

Issues/Additional Needs: No other issues or additional needs have been identified.

Staff Recommendation:

Staff recommends approval of up to \$34,000 from the Yampa/White/Green Basin Account and \$66,000 from the Statewide Account to help fund the project: Maybell Diversion and Headgate Project Telemetry

Water Activity Summary: If approved, WSRF funds will assist in purchasing of telemetry equipment as a critical component of updating and modernizing the Maybell irrigation diversion in the Lower Yampa. New remote transmission and receiving equipment will allow for easier operation and more precise control of irrigation water after many decades of disrepair.

The project will modernize irrigation infrastructure, increase agricultural efficiency, benefit designated critical habitat of four endangered fish (the Humpback chub, Bonytail, Colorado Pikeminnow, and the Razorback Sucker), and improve safety for recreational boaters.

Maybell Irrigation District diverts approximately 20,000 acre-feet annually to serve 18 producers and nearly 1,200 acres of hay pasture. This project will improve flows and habitat connectivity in at least 21 miles of the Yampa River and support the recovery of the four endangered fish while meeting water users' long-term irrigation needs. Partnerships between agricultural, environmental, and recreational interests are critical to increasing resilience to drought and climate impacts for the local community, river recreationists, native fish, and the riparian corridor.

The entire project of rehabilitating the Maybell Diversion is estimated to cost \$2.9 million. CWCB has awarded \$73,000 of Yampa/White/Green Basin funding for the engineering and design of the headgate modernization efforts at the May 2019 CWCB Board Meeting. This phase of the project is scheduled to finish in December 2021.

Discussion: This project meets with several measureable outcomes in the Yampa-White-Green Basin Roundtable's Basin Implementation Plan including: protecting and encouraging agricultural uses of water in the basin within the context of private property rights; improving agricultural water supplies to increase irrigated land and reduce shortages; quantify and protecting non-consumptive water uses; restore, maintaining and modernizing water storage and distribution infrastructure; developing an integrated system of water use, storage and administration and delivering water shortages and meeting environmental and recreational needs; and the providing for multiple beneficiaries.

Issues/Additional Needs: No other issues or additional needs have been identified.
