Montezuma Orchard Restoration Project (MORP) owns 36.35 acres of residential/agricultural land near Cortez, Colorado, irrigated with 35 shares of Montezuma Valley Irrigation Company water. Historically the property was used for orchards, but the majority of the trees were cut out by 1960 in favor of water intensive crops such as alfalfa.. The property known as the Orchard Hub is located in the San Juan basin on lands that use water from the Dolores River basin.

This project will help facilitate the objectives of MORP's by constructing the sustainable indoor infra-structure needed to conduct economic activities around teaching the benefits of water conservation and preservation in orchards while providing value-added opportunities to grow the Southwest region's fruit economy. Specifically, funds will be used to construct a 3,000 square feet, insulated steel building for apple and juice storage to conduct mobile juice operations.
