## Introduction:

On November 4, 2021, the CWCB received fourteen Colorado Watershed Restoration Program (CWRP) grant applications with requests more than \$50,000, totaling \$3,589,176 in requests. A committee of four people reviewed these requests and staff is recommending at least partial funding for all applications, totaling \$2,315,783. See the attached data sheets for locations and project summaries.

## Staff Recommendation:

Staff recommends the following Board actions for activities regarding the CWRP grant funding. Project approval is contingent upon the applicants' abilities to resolve issues and additional needs discussed below.

## Staff Review and Comments:

Staff reviewed the applications as a committee, taking into consideration comments from both GOCO and CPW. Due to the number of applications received and the limited amount of funds available, over half of the applications received a recommendation for partial funding.

## Project Issues/Additional Needs:

- All funding awards are contingent upon the applicants' ability to secure match funding.
- Grantees should adequately address CWCB staff comments to scope of work and engineering designs (when applicable). Staff contact each successful applicant to discuss comments and contracting procedures.
- All grantees should adhere to their organizational procurement policies when hiring contractors and consultants. CWCB recommends that State procurement policies be used as a guide if an organization does not have procurement policies.
- Projects should comply with the CWCB's Rules and Regulations for Regulatory Floodplains in Colorado, when applicable.
