Metro Roundtable Business Meeting

1. Demand Management Discussion (*Attachment 6*) One motion passed to further discuss Demand Management.

Mary Gearhart discussed the South Platte position of wanting to be a part of the solution. The SPB Demand Management statement has been distributed to MRT and can be found on the SPB website, https://southplattebasin.com/demand-management/.

There was suggestion to sign onto the SPBRT position or prepare a similar paper and submit to CWCB. The Lower basin states have a narrative started suggesting that the Upper basin states are not taking demand management seriously or taking necessary action. The more awareness MRT has on this issue will help assist informing the dialogue. Suggested the best way MRT could support is to act in role of review. How can MRT help the State provide a uniform front and advocate for Colorado? Make it clear how Colorado deals with shortages every year. Colorado does need to speak as one voice on this issue. It would be helpful to have the MRT voice in this conversation.

MRT consensus is to keep the momentum going on the Demand Management tool. If we can't prove we can put the tool to good use by 2026 we could lose the funding in the interim. Unless something changes in the interim negotiations the pool will only allowed to be filled until 2026. The tool is an insurance policy. PEPO should be given strong direction on marketing this issue and the Drought Contingency Plan (DCP).

Members will consider a letter from MRT urging CWCB to continue to complete the work to continue the Demand Management Plan and continue to fund it.
