#### **EXECUTIVE SUMMARY**

#### **Background**

On Oct. 14, 2020, the East Troublesome Fire was reported northeast of Kremmling on the Arapaho National Forest. With high winds and low humidity in the following weeks, the fire's final acreage reached 193,812 acres by the time it was fully contained on Nov. 30. Grand County and Northern Water immediately began working with partners on watershed restoration and planning of projects to mitigate threats to life and property due to post-fire flood, sediment, and debris.




Figure 1 – East Troublesome Fire EWP Program Sponsor Areas

In February, the Grand County Board of Commissioners and the Northern Water Board of Directors agreed to be the USDA Natural Resources Conservation Service (NRCS) Emergency Watershed Protection (EWP) Program sponsors for different geographical areas of East Troublesome Fire recovery efforts. Northern Water is project sponsor for Area A and Grand County is project sponsor for Area B (See Figure 1). As sponsors, Grand County and Northern Water worked with NRCS to prepare Damage Survey Reports (DSR) of non-federal lands in the affected areas. Teams performed field assessments to identify potential post-fire hazards to life and property that may occur in coming months and years, developed potential treatments to mitigate hazard risks and estimated treatment costs.

#### **EWP Funding Requirements**

Through the EWP Program, NRCS provides reimbursement up to 100% of design and engineering cost as part of their Technical Assistance (TA), and up to 75% of construction costs as part of their Financial Assistance (FA). NRCS requires the 25% local match to be sourced by the project sponsor. The CWCB Grants, as further described below, were provided to in part cover the 25% local match for EWP implementation projects.

### **CWCB Grants Summary**

For purposes of the CWCB Grant, Northern Water is the Grantee and serves as the Fiscal Agent for funds directed to Grand County. Contracting was accomplished over three grant cycles as CWCB and NRCS funds became available.

On June 3, 2021 CWCB executed CTGG1 2021\*3428 for \$1,500,000 covering approximately 15% of the anticipated work under the EWP Program. On July 30, 2021, \$2,650,000 of grant funds were amended into the contract which would allow for approximately 46% of the EWP Program. On September 28, 2021 CWCB issued a new contract CTGG1 2022\*2360 in the amount of \$4,663,524 which would allow for 100% of the EWP Program to be carried out.

## Task 1 – Grand County Watershed Recovery Watershed Program Coordinator

**Purpose:** This task provided funds to Grand County to help with overall project management for the East Troublesome Fire as well as the liaison for landowners affected by the Williams Fork Fire. Grand County recognized the significant amount for work that would be required in providing outreach to landowners, procuring required landowner agreements and necessary permits to help expedite project design and implementation to meet the EWP timeline as well as working closely with the County contracted engineering, design, and construction group to ensure projects meet the needs of the community and EWP program requirements, including accounting requirements for reimbursement submittal to NRCS.

**Result:** Brian Murphy of River Works was contracted with on September 7, 2021, as the Grand County Watershed Recovery Coordinator for Area B. Brian provides overall project management for the East Troublesome Fire EWP Program and is the liaison for landowners affected by the East Troublesome Fire (ETF) in Area B. This task is complete and was fully funded under CTGG1 2021-3428.

Deliverable: Northern Water's subgrantee agreement with Grand County is attached as Attachment A

## Task 2 – EWP Program Implementation Area A (Northern Water)

**Purpose:** This task provided the local match for EWP projects in Area A, generally described as the East Troublesome Fire burn area and affected areas upstream of Windy Gap Reservoir. Implementation efforts under this task includes mitigation treatments as identified in the Damage Survey Reports (DSRs) for Area A. Mitigation treatments generally fall into one of the four categories of EROSION CONTROL (incl. seeding/mulching, Log erosion barriers, mastication, bank stabilization), SEDIMENT/DEBRIS CONTROL (incl. debris removal, debris booms, sediment basins, sediment removal), FLOOD PROTECTION (incl. flood barrier bags, overflow channels), and OTHER (incl. emergency warning system, ditch/canal improvements, road & bridge protection, trash racks).

**Results:** In 2021, fourteen (14) projects were completed under the EWP program in Area A, including the mulching of 4,660 acres. A total of nine (9) projects are active or planned for completion in 2022. This task is not complete though funding under CTGG1 2021\*3428 has been exhausted. This Task will continue into Summer of 2022 to be funded through the CTGG1 2022\*2360.

### Task 3 – EWP Program Implementation Area B (Grand County)

**Purpose:** This task provided the local match of EWP Projects in Area B, generally described as the East Troublesome Fire burn area and affected areas downstream of Windy Gap Reservoir. Implementation efforts under this task includes mitigation treatments as identified in the Damage Survey Reports (DSRs)

for Area B. Mitigation treatments generally fall into one of the four categories of EROSION CONTROL (incl. seeding/mulching, Log erosion barriers, mastication, bank stabilization), SEDIMENT/DEBRIS CONTROL (incl. debris removal, debris booms, sediment basins, sediment removal), FLOOD PROTECTION (incl. flood barrier bags, overflow channels), and OTHER (incl. emergency warning system, ditch/canal improvements, road & bridge protection, trash racks).

**Results:** In 2021, seven (7) projects were completed under the EWP program in Area B including the mulching of 391 acres. A total of seven (7) projects are active or planned for completion in 2022. This task is not complete but funding under CTGG1 2021\*3428 has nearly been exhausted. This Task will continue into construction season of 2022 and will be funded through the CTGG1 2022\*2360 once funding under CTGG1 2021\*3428 has been exhausted.

Work continues on both Tasks 2 and 3. Northern Water will start drawing on CTGG1 2022\*2360 for Task 2. Grand County will draw on their remaining \$147,151.97 in future pay request for Task 3 work prior to drawing on CTGG1 2022\*2360 funds.

### **Conclusions and Discussion**

Recent Colorado fires have proven how important watersheds are to water providers and the population they serve. One specific challenge to affected entities in attempting to provide post-fire watershed recovery efforts, is that the various land ownership breakdown of a watershed presents a difficult path to recovery as water providers do not have direct control of their watersheds. The land ownership challenge is increased when there are also multiple federal entities that are landowners as each federal entity has their own budgetary restrictions and can have differing opinions on best, or even allowed, treatments.

The EWP program helps to solve this problem on private lands as individual landowners often do not have the financial or technical resources to carry out watershed recovery efforts on their own, much less attempt to plan efforts at the watershed scale level. Water providers are in a better position to plan, design, and implement these treatments but must rely on federal funding to provide the financial resources to do so. As the EWP sponsor is still responsible for providing the 25% cash match on said treatments, CWCB's ability to provide these types of grants proves invaluable and produce a 3:1 return on the state's investment in federal dollars.

Funding is however only one piece of the puzzle. As project's go from conceptual to planning levels, individual landowner agreements are required which can sometimes be a roadblock to implementation as some landowners can be difficult to reach and some choose to not participate for any variety of reasons. A number of proposed projects did not go forward due to an inability to obtain landowner consent. This is one reason why not all funds from Task 2 and 3 may end up not being spent at the end of the EWP Program.

Under the EWP program, a large portion of funds have been and will be provided for aerial mulching operations. Using a portion of CWCB grant funds that were originally identified as EWP match for Area A, a fourth Task was created under CTGG1 2022\*2360 for the purpose of conducting a mulch efficacy study through Colorado State University and USFS Rocky Mountain Research Station. This study will be able to better inform future post-fire mulching projects by looking across a range of scales in nested mulched and unmulched watersheds. The findings and implications of this work are intended to be informative for watersheds statewide.

Though not yet finished, the EWP program which these grants are helping to fund have proven to be a success, in not only providing treatment efforts on the ground, but also in bringing multiple entities together in addressing post-fire recovery at the watershed scale level. Monitoring will occur through the mulch efficacy study but also as the project sponsors provide O&M on installed point treatments.




Figure 2 – Completed EWP projects. See also: <u>https://www.northernwater.org/GC-Watershed-Recovery/recovery-map</u>

## AMENDED MEMORANDUM OF UNDERSTANDING OF NORTHERN COLORADO WATER CONSERVANCY DISTRICT (NORTHERN WATER) AND GRAND COUNTY COLORADO

## Grant Award CMS Numbers 169700, 170501, and 171542 Colorado Water Conservation Board 2020 EAST TROUBLESOME FIRE

#### RECITALS

WHEREAS, the parties named above sought funding jointly through the Colorado Department of Natural Resources, Colorado Water Conservation Board, related to the East Troublesome Fire; and,

WHEREAS, on June 3, 2021 the parties were notified of approval of \$1,500,000 in grant funding (CMS 169700) and the grant award is attached hereto and incorporated herein as Exhibit A and,

WHEREAS, on July 30, 2021 the parties were notified of approval of \$2,650,000 in grant funding (CMS 170501) and the grant award is attached hereto and incorporated herein as Exhibit B and,

WHEREAS, on September 28, 2021 the parties were notified of approval of \$4,663,524 in grant funding (CMS 171542) and the grant award is attached hereto and incorporated herein as Exhibit C and,

WHEREAS, Northern Water is the fiscal agent under the grant award, and the parties intend to coordinate in order to provide efficiency in their efforts in financial and other matters concerning such grant award. Grand County was awarded Task 1 and Task 3 and Northern Water was awarded Task 2.

#### **Memorandum of Understanding**

1. **AUTHORITY.** This MOU has been duly adopted by the parties' governing bodies and the undersigned representatives are authorized to execute this MOU on behalf of each respective party.

2. **PURPOSE.** The foregoing Recitals are hereby incorporated into and made part of this MOU.

3. **PAYMENTS.** Payments to Grand County as subgrantee for the following tasks as numbered and identified in the grant award include:

i. **Task 1.** Grand County Watershed Recovery Program Coordinator: \$150,000 reimbursement paid as follows: Upon notification by Grand County of its intent and commitment to hire a watershed recovery program coordinator under this task,

Northern Water will be obligated and committed to provide \$150,000 to Grand County. Northern Water's obligation is conditioned upon receiving such funds from CWCB under this task. Payment to Grand County will be due 10 calendar days after Northern Water has received Task 1 funds from CWCB. Northern Water's actual obligation amount will be equal to the actual payment amount it receives from CWCB under Task 1. Grand County is solely responsible for the advertisement, hiring, and oversight of the coordinator position and warrants that funds received by Northern Water will be restricted and reserved solely for costs and expenses related to the watershed recovery program coordinator position. In the event that funds are not fully utilized for the Task 1 purpose, Grand County shall apply such funds to Task 2 or Task 3 of the CWCB grant.

- ii. Task 3. EWP Program Implementation Area B \$1,357,924 paid as follows: Grand County will submit invoices to Northern Water incurred under Grand County's EWP Program for Area B. Northern Water will provide invoices to CWCB for grant reimbursement at a rate not to exceed 25% of eligible invoices, up to a maximum cumulative amount of \$1,357,924. Upon payment by CWCB to Northern Water for Task 3 work, Northern Water will submit a payment in the same amount to Grand County. Northern Water is not responsible for payment to Grand County until and unless invoices are approved by CWCB and payment has been received by Northern Water. Northern Water will submit grant reimbursement requests to CWCB no more frequently than on a monthly basis.
- iii. **Task 2.** Northern Water was awarded Task 2 therefore, no payments to Grand County will be made for Task 2.

4. **INVOICE ELIGIBILITY**. For invoices to be eligible for reimbursement, work must be performed in compliance with NRCS EWP program requirements and CWCB grant program requirements. Northern Water will act in good faith to resolve any invoice or payment dispute between CWCB and Grand County, but Northern Water is not responsible for ensuring compliance with NRCS and CWCB requirements for resolution of such disputes.

5. **COMPLIANCE WITH STATE AND FEDERAL REQUIREMENTS.** Both parties agree to timely comply with all state and federal laws. Grand County agrees to cooperate with Northern Water in providing the required documentation as specified in the attached Grant Award (Exhibit A) including information related to progress reports and the final report.

6. **NOTICE.** All notices, demands, or other written communication required or permitted to be given by this MOU shall be by electronic mail, hand delivered or sent by certified or registered mail, postage prepaid, and return receipt requested, to the parties at their most recent address of record.

10. **AMENDMENTS.** Any amendments or modifications, not including the addition of parties by signatures below, to this MOU must be in writing and executed by all parties to be valid and binding.

11. **SEVERABILITY.** If any provision of this MOU is invalidated by any court of competent jurisdiction, the remaining provisions shall continue in full force and effect.

12. **TERMINATION.** This MOU shall automatically terminate without further action of the parties at the termination of the CWCB Grant or sooner by written notice to the other party.

13. **THIRD PARTY ENFORCEMENT- NONE.** This MOU and all rights and obligations are reserved solely to the signing parties and not any third party. This MOU does not create any rights to any third parties.

  - c. Stream crossing protection, sediment management and erosion control measures along the stream corridor

  - a. After several negotiations on design, ditch owners ultimately rejected design engineers' recommendation and declined to participate in the EWP program.
