## Introduction

On July 1, 2022, the CWCB received 7 applications requesting funding of \$100,000 or greater for the Water Conservation and Land Use category totaling \$1,060,497.75. Staff is recommending approval of 7 grants totaling \$1,060,497.75. Item 7d. is in the Conservation and Land Use grant area but the funds will be taken out of the Watershed Health and Recreation grant area. In the end, the total for the Conservation and Land Use grant area will be actually be \$870,497.75. Staff did recommend one grant for funding which is in the Consent Agenda for \$62,500 and two grants for under \$50,000 that were on the Director's Report. See attached Data Sheets for locations and project summaries.

## Background:

CWCB staff, with assistance from a review committee, review all water conservation and land use applications according to the Colorado Water Plan Grant Program criteria and guidelines and category specific criteria. The grant review committee consists of Colorado Water Conservation Board staff in consultation with Colorado Department of Local Affairs where appropriate. The review committee evaluates water conservation and land use grants on several criteria including whether the project furthers critical action items identified in the Colorado Water Plan, whether the project promotes collaboration, and whether the project provides an innovating, multi-benefit approach to solving water resource challenges affecting Colorado's municipal sector.

## Project Issues/Additional Needs:

- All funding awards are contingent upon the applicants' ability to secure match funding within a reasonable time period; based on applicants continued efforts to secure match funding
- Grantees should adequately address CWCB staff comments to scopes of work and engineering designs (when applicable) prior to contracting. This may result in changes, especially in the case of partial funding awards. Staff will schedule meeting with each successful application to discuss comments and contracting procedures.
