#### Background:

For this agenda item, the Board is provided with a brief overview of applications to the Water Supply Reserve Fund (WSRF). Attachments to this memo include:

- Summary spreadsheet detailing funding requests for the basin and statewide accounts;
- Summary spreadsheet displaying current WSRF Balance Summary of Fund Appropriations and Receipts by Fiscal Year, and Fund Distribution by Basin and Statewide Account.
- Water Activity Summary Sheets, which provide an overview, discussion, issues/additional needs, and staff recommendation regarding funding, partial funding, or not funding the applications.

Staff's review of the applications involves the following steps:

- 1) Applications are reviewed for completeness based on the information requirements, which are primarily outlined in the Grant Guidelines.
- 2) Applications are reviewed to verify that the water activity meets the eligibility requirements, which are based on the requirements of Section 39-29-108 (III) C.R.S., and two sections of the Water for the 21st Century Act (House Bill 1177); Section 37-75-102 and Section 37-75-104(2)(c) (C&G, Part 3). Staff also verifies that the applicant was an eligible entity to receive funding.
- 3) Staff then prepares the Water Activity Summary Sheet which documents the outcome of the review process and contains staff's recommendations.

#### Staff Recommendation:

Staff recommends approval of up to \$100,000 from the Arkansas Basin Account to help fund the project: Hale Reservoir Renovation - Cross Creek Park.

Project approval is contingent upon the applicants' abilities to resolve issues and additional needs discussed below.

Water Activity Summary: The applicant proposes to achieve five goals with this project including: 1) rehabilitate Hale Reservoir dam, increasing the size of the lake and surrounding wetlands; 2) create a non-potable irrigation source for the park's multi-use fields; 3) increase and improve environmental attributes and habitat; 4) create recreational amenities that allow open space access without damaging habitat; and 5) address and correct water quality and flood hazard issues with stormwater mitigation infrastructure.

WSRF funding will be used specifically to build the non-potable irrigation system. A pump house, with filtration system, and irrigation infrastructure, will be built adjacent to the enlarged lake.

New capacity for 72-hour stormwater storage of 10+/- acre-feet, combined with water quality mitigation infrastructure, will support creation of 7.5 or more acres of new wetland habitat (10-15 acres with buffering features). The new pond will provide a source for non-potable irrigation for the park's five acres of turfed recreation facilities, conserving 10-15 acre-feet of potable City of Fountain water each year. Combined with restoration of 3.5+/-acres of existing wetland and educational recreational amenities, including an ADA-accessible fishing pier and boardwalk, this community asset will become a showcase for

multi-purpose water resource projects. Educational signage will enhance the communities' enjoyment of the upgraded environmental assets.

**Discussion:** This project supports the Colorado Water Plan by demonstrating a commitment to collaborating with project partners to meet multiple needs, conserving in 10-15 acre feet of potable water per year, addressing the gap in the Arkansas River Basin and providing recreational and environmental opportunities.

**Issues/Additional Needs:** If approved, the applicant will need to secure matching funding prior to contracting. No issues or additional needs have been identified.

Eligibility Requirements: The application meets requirements of all eligibility components.

Evaluation Criteria: Staff has determined this activity satisfies the Evaluation Criteria.

#### Staff Recommendation:

Staff recommends approval of up to \$139,500 from the Yampa/White/Green Basin Account to help fund the project: Stillwater Reservoir Repairs & Upgrades.

Project approval is contingent upon the applicants' abilities to resolve issues and additional needs discussed below.

Water Activity Summary: If approved, WSRF funds would assist both phases of the applicant's proposal. The first phase, involves the applicant obtaining accurate cost estimates for the alternatives to mitigate seepage from the left abutment of Stillwater Reservoir. The cost estimates will enable the applicant to select the most efficient and effective repair projects from a list of alternatives already presented to them that are acceptable to the Division of Dam Safety/Division of Water Resources (DWR). This will allow the applicant to develop a detailed design plan for submission to DWR for final approval of the repair projects.

The second phase is to replace the outlet's hydraulic power unit, hydraulic reservoir and hydraulic lines with the recommended upgrades and encase the new lines in conduit. These upgrades to the original 1939 equipment will ensure that the outlet system has optimal capability for safe and efficient operation now and for the foreseeable future.

**Discussion:** This aligns with several goals in the Yampa-White-Green Basin Implementation Plan including: Protecting the Basin from compact curtailment of existing decreed water uses and some increment of future uses; Protecting and encouraging agricultural uses of water in the YWG Basin within the context of private property rights; Improving agricultural water supplies to increase irrigated land and reduce shortages; Identifying and addressing M&I water shortages; Restoring, maintaining, and modernizing water storage and distribution infrastructure; and developing an integrated system of water use, storage,

administration and delivery to reduce water shortages and meet environmental and recreational needs

Issues/Additional Needs: No issues or additional needs have been identified.

Eligibility Requirements: The application meets requirements of all eligibility components.

Evaluation Criteria: Staff has determined this activity satisfies the Evaluation Criteria.
