# Summary of Water Court Application

Application for Simple Change of Diversion and for Absolute and Conditional, Surface, Underground and Storage Water Rights.

## **Staff Recommendation**

Staff recommends that the Board ratify the filing of a Statement of Opposition filed on behalf of the Board in November 2022 to protect CWCB's instream flow water rights.

## **CWCB Instream Flow Water Rights**

The CWCB holds water rights, including the following instream flow water right in Water Division 7 in the Animas River Watershed, that could be injured by this application:

# Potential for Injury


- The proposed change in point of diversion could cause an expansion of use which could injure the CWCB's instream flow water right.
- The claimed beneficial uses of augmentation and aquifer recharge are unclear.
- Applicant's claim for a simple change of water right for the Teti Canyon Ditch may be inappropriate because the application includes other claims involving this water right and the claimed simple change of water right which appears to be prohibited by section 37-92-305(3.5)(III)(C), C.R.S.

Should it be determined that one or more of the above-described ponds do encounter groundwater, Applicant requests, in the alternative and as applicable, underground water rights for pond wells for the same amounts and uses described above and will apply for a well permit for any such pond well prior to entry of a decree. 5. Applicant is the owner of the land upon which all of the above structures are or will be constructed except for the Brown Ditch Enlargement, which crosses land owned by Jeffrey R. and Leslie A.
