A funds update was given before grant proposals. We started with \$1m in October. The annual spending allocation is \$400,000. We have a balance of \$854,172.

4:15 - 4:35 pm WSRF Grant Application – Lysimeter Continuation Grant

Wendy Ryan - Colorado River Engineering

The requested amount from Wendy is \$100,000. This will be a continuation of the study that took place from 2016-2022. The usable data from this time period took place from 2018-2021. This study looks and compares data to CoAgMet. The lysimeter shows more consumptive use in the study. The data compares against the alfalfa reference. The focus has been on when the period when water was being applied. In July the use was 24% higher. Some of the impacts on this study included height of the grass for the CoAgMet data. The lysimeter tends to green up faster and may have limited water availability. The three state agreement ac/ft is much lower then the data collected has shown. For now the tasks include equipment procurement, research and purchase of additional soil moisture sensors for surrounding fields, running and monitoring of lysimeters, and data analysis and reporting. There were no questions and the vote passed with all yes' for approval of the project.

The CWCB Loan Program is a 52 year old program. There are lots of grants available. The loans are low interest. They are for design and construction of untreated water infrastructure projects. In the past there have been three projects to use this program in Jackson

County; 1981, 1990, and 1994. The loan reviews are six times a year. There is a feasibility study required and this can be difficult. The Michigan River has used this and it was helpful.
