WSRF recommends funding at \$40,000. If this is the approved amount, OWF asked for direction on preferred focus for the funding. Future maintenance costs will involve manual intervention for updates. There will be a continual need to pursue funding and OWF intends to actively work on the site. With reduced funding, OWF would speak with the stakeholders and likely reduce the datasets and views.

MRT approved the application to move forward to a full submittal.

2. Wadley Farms - Wadley Farms 3 Lake #1 Rehabilitation
WSRF recommends funding at \$15,000. This is located in unincorporated
Adams County. It is a dam safety project to bring the dam up to current
safety standards and is aging infrastructure.

Colorado Geologic Survey – <u>South Platte Basin Geologic Salinity Sources – Geologic Formation Chemical Characterization</u>
 WSRF recommends funding at \$40,234.50. CGS is putting in \$25,000 as match. If the SPBRT does not approve, CGS would not be able to move

forward this year.

 WSRF recommends funding at \$25,000.00.

7. Colorado Airborne Snow Measurement Program ASO Flights Update (Taylor Winchell, Denver Water)(10 min.) Metro – CUSP-ASOFlights NTP POGG1 2023-3284 ExhA&B CASM plans to apply for a USBR grant and asked for a letter of support for that application. This project conducts ASO flights in the Upper South Platte Basin to accurately measure snowpack. The flights are slotted to happen on Sunday to conduct Lidar measurements. This activity is weather dependent.

MRT approved a letter of support for the CASM USDR grant application.

The draft of the Supplemental Environmental Impact Statement on the Bureau of Reclamation alternatives information and survey below.

• Supplemental Environmental Impact Statement

On April 11, 2023, the Bureau of Reclamation released a draft Supplemental Environmental Impact Statement (SEIS). The SEIS is a mechanism to adjust the current operating guidelines for Glen Canyon and Hoover Dams, providing tools for Reclamation to adapt to potentially dry years in the next few water years. Commissioner Mitchell relies on public input to inform Colorado's response to the SEIS. What are the issues that concern you the most? What should the Bureau of Reclamation consider in its changes to the operating guidelines? Your input may be recorded, anonymized, and presented online at a later date.
