Staff Recommendation: Staff recommends the Board approve a loan not to exceed \$9,847,500 (\$9,750,000 for project costs and \$97,500 for the 1% service fee) to the Board of Water Works of Pueblo for costs related to the Southside Diversion Dam Improvement Project, from the Severance Tax Perpetual Base Fund. The loan term will be 20 years at an interest rate of 2.25% per annum. Security for the loan shall be in compliance with CWCB Financial Policy #5. Additionally, staff recommends the following supplemental condition to be included in the loan contract:

1. This loan shall receive a second-lien priority on the Board of Water Works of Pueblo's net revenues to existing Water Revenue Bond Series 2019 obligations.
