Request for Final Action on Uncontested ISF and NLL Water Rights in Water Divisions 1, 4, 5, and 6

Action: Report by CWCB staff member Rob Viehl. A motion to approve the staff recommendation was made by Barbara Vasquez, which was seconded by Robert Sakata. The motion was approved unanimously (8-0).

Staff Recommendation: Staff requests that the Board make the following determinations and take the following actions on each instream flow (ISF) water right listed in Table 1, and on the natural lake level (NLL) water right listed in Table 2. The information necessary to support these determinations is contained in this memo, the recommendation letters and documentation submitted by the Bureau of Land Management (BLM), Colorado Parks and Wildlife (CPW), and High Country Conservation Advocates (HCCA), and in staff's memo and oral presentation provided at the January 24, 2023, Board meeting.

- (1) Determine, pursuant to section 37-92-102(3), C.R.S., that for the ISF and NLL appropriations identified in Tables 1 & 2:
- (a) There is a natural environment that can be preserved to a reasonable degree with the recommended water rights, if granted;
- (b) The natural environment will be preserved to a reasonable degree by the water available for the recommended appropriation; and
- (c) Such natural environment can exist without material injury to water rights.
- (2) Pursuant to ISF Rule 5f., establish January 24, 2023 as the appropriation date for these water rights.
- (3) Request staff to work with the Attorney General's office to file applications for these water rights in water court by the end of the calendar year.

Public Comment and conditional Approval of Terms and Conditions for ISF Water Rights in Water Division 4 on Cottonwood Creek, Monitor Creek, and Potter Creek (Montrose & Delta Counties)

Proposed Water Use Agreements with the Ute Water Conservancy District and Garfield County to lease Ruedi Reservoir Water for Instream Flow Use in the 15-Mile Reach (Water Division 5) (2nd Meeting)

Action: Report by CWCB staff member Pete Conovitz. A motion to approve the staff recommendation was made by Steve Anderson, which was seconded by Jackie Brown. The motion was approved unanimously (8-0).

Staff Recommendation: Staff recommends that the Board:

- 1) Direct Staff to execute the proposed Water Use Agreements with a) the Ute Water Conservancy District; and b) Garfield County in a form substantially similar to the attached draft Agreements;
- 2) Authorize an expenditure of up to \$247,200 to implement and fund the first short-term annual lease under the Agreement with the Ute Water Conservancy District; and
- 3) Authorize an expenditure of up to \$16,548 to implement and fund the first short-term annual lease under the Agreement with the Garfield County.

Pursuant to 37-92-102(3) C.R.S. and ISF Rule 6b, this meeting is the second of a two-Board meeting process to review, consider any public comment, and approve or reject a proposal for two separate Water Use Agreements that allow for the short-term annual lease of water for instream flow use on the 15-Mile Reach of the Colorado River. No request for a hearing was received following the initial presentation of this proposal at the March 2023 Board meeting. At this meeting, the Board may direct Staff to execute the Water Use Agreements and authorize funding to implement the first short-term annual lease under each Agreement.
