Dear Ben,

This letter serves as the final report and reimbursement, for the CWCB Colorado Water Plan Engagement and Innovation grant in the amount of \$98,375.00 that the Ditch and Reservoir Company Alliance (DARCA) received on July 14, 2022.

The grant scope addresses Colorado's Water Plan, its identified concerns, provides education, and promotes action through multiple outreach mechanisms. The projects/programs include:

TASK 1: Ambassador Program TASK 2: Grant and Project Management

The total amount for reimbursement totals \$20,805.50 and the cash match amount totals \$7,970.75. In-kind match totals \$1,400.

Task 1- Ambassador Program

Seven Ambassadors were selected for the first iteration of the DARCA Ambassador Program. Of those, five are active in the Program. The Program is near the end as we wrap up the advocacy section of our program. This is the most exciting section for our Ambassadors, however we are waiting on our partner, the Colorado Water Congress, for details on the tour and information that will be shared there. Once the Ambassadors receive more in depth and in person content, it will be easier for the Ambassadors to share their perspectives and projects.

Feedback has already been received by the Executive Director that the content is helpful and the Ambassadors are learning a great deal in the Program. The Ambassadors are happy and willing to "dig in" to the content and perform additional research.

The only remaining items in the program for the Ambassadors to complete are a tour to the Capitol in person, two videos, and a presentation on their advocacy project. All final projects will be uploaded by each Ambassador.

The Future of the Ambassador Program

While the DARCA Board and Executive Director found the information compelling and helpful for the participants and it was well-received by the Ambassadors, at the annual in-person board meeting for the DARCA board, it was discussed in detail. It was then decided that the content we can really help and provide lies in the direct management and maintenance of water delivery structures and systems and that isn't something we can provide in video form. In addition, there are so many wonderful programs existing that we do not want to oversaturate the existing market. We will, however, provide these videos for our members in addition to our resource guides and handbook and will be shared with additional partners. The Colorado Department of Agriculture has already asked to see the Water 101 videos and those have been shared. Additional partnerships are being formed. We see this venture as a positive one and one that will continue to live on, just not in the same format moving forward. We are able to reach more people in a non-structured format for our members and partners rather than a whole program which allows us to support other entities who have their own programs.

Task 2 – Grant and Project Management

Amber Weber, Executive Director, has communicated and worked with all partners who are responsible for providing in-kind support and for the implementation of the work detailed in this grant.

Weber performed the organization, coordination, task management, and reporting on all Ambassador Program details and work related to such. The Executive Director has monitored and reported on all DARCA grant-related activities to CWCB and the DARCA board of directors.
