Department of Water Resources, Division 2 - Rachel Zancanella, Division 2 Engineer presented

a summary about 2023 Division 2 water conditions, including snowpack, spring runoff, operational challenges, and flooding, as well as how those conditions affected the Arkansas River Compact and its administration.

Rachel gave an overview of the 2024 Division 2 administrative priorities, beginning with the Pond Management Program. Phase 1 of the program includes a 5 mile buffer on either side of the Arkansas from Pueblo to the New Mexico – Colorado state line. She summarized the program's scope of work, educational program, challenges, communications, and the administration and coordination involved. Public relations is considered a priority in this program, as well as environmental impacts of filling illegal ponds.

Another 2024 priority is the Refined Futile Call Administration, about physically and legally connected groundwater and surface water. Division 2 will hold public meetings on this topic, which are posted on the DWR website: https://dwr.colorado.gov/events.

The next 2024 focus Rachel discussed was priority administration and Colorado's Decision Support Systems (CDSS) Tools. The Colors of Water Tool is now live, and they are looking for feedback during the season. The scenario planner and transit loss tools are also available. These tools may be found on the CDSS Tools website at https://cdss.colorado.gov/.

Rachel took questions from Roundtable members.

Colorado Water Conservation Board – Russ Sands presented an overview of the CWCB Guide for Roundtables draft. The purpose of the Guide is to define how CWCB, Roundtables, and IBCC coordinate, as well as answer common questions typically asked to CWCB staff, to provide a useful resource for Roundtables, particularly new members. The Handbook/Guide will cover conflicts of interest, code of ethics, Colorado Open Meetings Law, Colorado Open Records Act, public comments, accessibility, and training. It will include reference materials and links. The schedule for implementation is to present to Roundtables January through Spring, have a full draft in Spring, a revised draft in June, and have full CWCB approval of the document in September (2024). Executive Committee – Mark Shea

Mark updated the Roundtable about the morning's executive meeting. The bylaws are being updated, and Mark gave an overview of the questions and discussion about recommended changes of the bylaws. The bylaws will be send to Roundtable members for review. The state "dredge and fill" legislation was discussed in

• Arkansas River Watershed Collaborative – Jonathan Paklaian

Jonathan gave a summary of the board meeting on February 12, 2024. Andy Lurch will be leaving ARWC after 5 years, so there will be some staff openings coming up. Wildfire ready watersheds application is nearly ready to be submitted. ARWC obtained a small office at the college in Salida. Mark suggested making the ARWC board meetings longer, as 2 hours was not enough time, extended a thank you to Andy Lurch, and mentioned sending out the job postings (including Middle Arkansas Basin coordinator, outreach coordinator positions).

Jeff Rodriguez updated the Roundtable about meetings and deadlines upcoming.

Director Greg Felt gave an update about new CWCB members. He also spoke about the January CWCB board meeting and Water Congress. The Water Quality Control Division and the CWCB had a joint meeting for the first time. They worked on finalizing the Shoshone permanency request and Projects Bill. Lake County was the one grant request under the Projects Bill for the Arkansas Basin, proposed by Sarah Mudge for \$151,000.

• Inter- Basin Compact Committee (IBCC) Report – Jeris Danielson

First meeting of 2024 will be February 27th in Denver. Russ Sands gave an overview of the agenda for that meeting – updates and reports in the morning session, and more PEPO-related discussions in the afternoon. Jeris and Terry will attend. Jeris plans to report on ARWC, PEPO, and the Arkansas Valley Conduit project. Terry mentioned discussions on how Colorado River issues affect the Arkansas Basin, and the Shoshone Power Plant Water Rights trans-basin concerns. • Needs Assessment Committee – Gracy Goodwin

Next Needs Assessment Committee meeting is Wednesday, February 28th at 2:00 pm. \$729,000 remaining in Arkansas Basin account. WSRF Application Deadline February 15th, so applications for WSRF grants should be sent to Gracy this week and presented at the March Roundtable meeting to be submitted in time for the April 1st deadline. Needs Assessment Committee meetings can be attended by any member of the Roundtable, and attending may be helpful to applicants during the pre-vetting process. Contact Gracy if interested in attending. The NAC provides recommendations for grants to the Roundtable, and the Roundtable provides an independent review and response to the project applicant.

Bob Hamel reported to the group about "scenic designation", snowpack, and working with media to help them report accurate information. Rena gave a brief update on Salida Lowhead Dam project and temperature reporting on Pueblo Reservoir downstream flows.
