1. Welcome/Introductions (Sean Chambers - 5 min.)

7. Due Process in SPBRT Membership Solicitation for Vacant and Inactive Seats (15 min.)



Going to the list and releasing an email blast to each county and municipality asking them to identify who could be a decision maker to participate. This may require volunteers from the RT to make direct requests in their areas. Part of recruitment could involve an Open House in lieu of a meeting with an introduction to the RT, its purpose and why it's important to the basin communities. The Open House could be the trigger for initiating the bylaw process to fill inactive seats.





3. CWCB Director Report (Director Sakata - 10 min.)

This is Director Sakata's final report. Colorado River Water Conservation District and Public Service Company signed an agreement that would allow the River District to purchase the water rights associated with the Shoshone power plant. The agreement has been conditionally approved.

Commissioner Mitchell and staff are hosting a series of public webinars to update the public on ongoing Colorado River Negotiations and answer questions. These are virtual.

11. Member Updates

A legislative session is underway. Bills were discussed. The RT shares information on the bills that have been introduced. We will continue to discuss these bills in the future. This relates to the purpose and significance of the SPBRT.

Action: Add legislative discussion as a standing item on the agenda to follow Committee reports in the February, March, and April of each year.

Arial Snow Observation (ASO) partners will be pursuing a single Lidar observation flight this year (April 2024) to continue the runoff forecasting pilot project across the northern Front Range Watersheds.

Northern Water recently went to Arizona to get updates on the Yuma and Salt River Ag and water efficiency practices there. A presentation may be of interest to the members on the outcome of this trip, Jim Hall will inquire with NCWCD.

A slide deck was provided by John Kolanz regarding two possible bills in the state legislature on dredge and fill legislation being proposed was presented. It highlighted the possibilities on where the bills each might place a State run dredge and fill program (DNR and CDPHE).
