This letter is to advise you that the Project referenced above was substantially completed on March 1, 2024. In accordance with the Loan Contract, the Company owes \$2,565.99 for interest accrued during the construction phase of the Project (see attached Project Expenditure Schedule). Please make this "interest only payment" check payable to the Colorado Water Conservation Board and include the Loan Contract Number on the check.

The final total loan amount under this contract is \$126,250.00 (\$125,000 plus \$1,250.00 for the 1% service fee). Billings Ditch Implementation Project

Billings Ditch Company Substantially Complete March 1, 2024



Project Description

The Billings Ditch Company (Company) is a non-profit corporation formed in 1884. It currently supplies surface water for irrigation to 11 shareholders east of the City of Monte Vista.

The Company partnered with the Colorado Rio Grande Restoration Foundation, the fiscal agent for the Rio Grande Headwaters Restoration Project, to organize and raise funds for the project. Funding came from a combination of this loan, a Water Plan Grant, and a North American Wetland Conservation Act grant from the U.S. Fish and Wildlife Service to cover the costs of final design, permitting, and construction. Construction began in the fall of 2021.

In March 2022, the contractor completed bank stabilization up and downstream of the diversion dam. This included channel shaping, construction of a floodplain bench, installation of rock stabilization structures, and planting of willow transplants. The contractor fabricated and installed new headgate, sluice gate, and 4-foot steel Parshall flume in time for the Billings Ditch to divert water at the start of irrigation season, April 1, 2022. The remaining construction activities were completed between May and June 2022 including reseeding all disturbed areas, installing the floating pipe trash rack, installing the conduit for the automation, and finishing the installation of riparian fencing.
