1. Welcome and Introductions -

- Introductions Mark called the meeting to order with introductions.
- Quorum was determined present, meeting commenced.
- Agenda approval by consensus.
- **Minutes of April 10, 2023** Approved by consensus, pending the additions of Jim Baldwin and Dan Williams in attendance.

2. Reports –

• Executive Committee – Mark Shea

Mark gave an update of the morning's executive committee meeting.

The "Dredge and Fill" House Bill HB1379 passed House and Senate and is on its way to the Governor's Office. A concern from members was that the program would be under management of CDPHE, which may not have the capacity for the program. The Sacket Gap waters were another – HB1379 includes all state waters and water features, with minimal exclusions, which would negatively impact many types of water users.

Colorado Water Plan grant program: Mark met with Lauren Duncan and Anna Mauss to gain clarity on information submitted on applications. Staff in-kind contributions can be considered on an application, if it is time specifically dedicated towards that project, tracked as such, and signed by a supervisor. CWCB has been discussing internally about how to define this more clearly for grant applicants. Lauren continued that grants that are submitted about water quality are more challenging to consider by the CWCB, which focuses mainly on raw water. CDPHE is the organization that focuses on water quality, and grants are available through their organization for water quality projects. These are items to more thoroughly discuss for water supply/reuse projects that come up. One specific project is from El Paso County Water Providers on Indirect Potable Reuse. That group plans to resubmit for the next round of grant funding.

Jean Van Pelt has offered to assist with Recorder and administrative responsibilities and develop a long term, sustainable program which could support the idea from the previous meeting of offering this kind of work to a college intern. Motion to move this program forward was approved by consensus.

• Arkansas River Watershed Collaborative (ARWC) – Jonathan Paklaian

ARWC applied for Wildfire Ready Watersheds proposal. Scope of Work focuses on Twin Lakes area. May 29 in Custer County, meeting for Stakeholders group. May 22-24 Colorado Mining Conference in Leadville. ARWC is collecting applications for a few different positions. An intern has been hired and will be starting this summer, she will start attending Roundtable meetings. Lake County chipping program, Jonathan can get interested members more information.

• Public Education Participation & Outreach (PEPO) – Ariel Hacker

Online attendees requested to write first and last names as their titles on Zoom so that attendance can be tracked more efficiently.

WECO's Upper Arkansas Basin tour: June 4-5 in Salida – the tour is full already FIBArk: June 13-16 in Salida; Jonathan, Maria, and Ariel discussed an outreach table on that Friday, where pamphlets and the WECO "Where Our Water Comes From" materials may be distributed.

Statewide Meeting was held May 3, which served as a great platform to collaborate with other PEPO coordinators for ideas and to hear what is going on in the state. Some good reminders and information from the CWCB presenters, and from WECO.

 PEPO has an overlapping grant that closes out at the end of November. The plan is to submit the June 1st grant to be all inclusive.

- What was discussed for the next round of funding was to continue reaching out to projects in underserved communities (aka narrowing down and closing out the project's list), and also doing more of the kinds of work that people think about when they hear "PEPO", like informational brochures about the Roundtable, BIP, PEPO, WSRF funding, attending water-related events to talk to people and distribute those and the WECO materials, do more updates on the website, possibly reactivate the Facebook page. If a volunteer likes creating social media content, maybe start an Instagram or other popular social media platform.
- WECO will continue to distribute materials in English and Spanish to Roundtables
- Members were encouraged to SPEAK NOW if they had ideas they would like to discuss. If any member feels strongly about certain topics being included, please attend the PEPO workgroup meetings.

Greg Felt provided an update on the CWCB board meeting. A new Chair was elected, Nathan Coombs, who will likely be elected as Chair when Greg steps down. CWCB will be electing a new Vice Chair. The next meeting will be in Granby on May 15-16. Executive session to be held on Demand Management, likely in response to Colorado River discussions. More discussions to be held on Shoshone Water Rights. The Dredge and Fill bills have been evolving and Greg feels that they have been improved.

Robert Sakata stated a formal thank you to Greg Felt for his service, and all members applauded.

The Water Forum in 2025 will be March 5-6 in Pueblo. Voluntary Flow Management Program discussed imports. It is anticipated that reservoirs will be full, so may not have room for the imports. What creative solutions exist to free up this water? Members are encouraged to reach out with ideas.

3. Presentation – Aurora Water Rights Purchase in Arkansas Basin

Rick Kienitz presented to the Roundtable about Aurora Water, its current Inter-Governmental Agreements (IGA's) in the Arkansas River Basin, and water rights acquisitions and interests. He summarized the 2024 Cooperative Farm Proposal in Otero County, its IGA, upcoming meetings to discuss impacts in Otero County. No changes in water rights or usage is proposed in the program, all existing leases and agreements will be honored. Rick provided an overview of the project

assets and assured the Roundtable that no "buy and dry" or changes in water rights will occur.

2024 Cooperative Farm Proposal

- Strong Agricultural Partner for farm with full farming in 7 out of 10 years and partial farming in the other 3 years.
 - Partnership continues during interruptible supply to Aurora
 - Look to make on farm improvements for labor and water savings
- Otero County Payments in Lieu of Taxes to keep County and communities whole - new IGA with Otero County
- Keep all lands in production no permanent dry up or change of water rights
- Continued partnership with current entities and agreements
- Compliance and cooperation with the Flow Management Agreement through Pueblo
- Compliance and cooperation with Voluntary Flow Management program
- Work closely with Catlin farmers to ensure non injury and strong support by City of Aurora



Rick answered questions from Roundtable members. Some farming will continue on the land. The river health is contemplated in the IGA, studies are likely to be funded to contribute to these studies. The water will pass through Otero Pump Station. County Commissioners expressed concerns about water supply limitations, particularly in the over-appropriated Arkansas Basin. The concern that anyone outside of the IGA may not be represented.

Motion to table this discussion to next meeting. Unanimous support.
