#### 1. Welcome/Introductions (Sean Chambers - 5 min.)

The meeting was called to order by Chair Sean Chambers at 4:16 pm.

The internet feed from the Owl device was lost, and while it was restarted, a PEPO update was provided by Casey Davenhill. Examples of content being developed for the 2024/2025 communications were provided. A request was made for the SPBRT to provide a Letter of Support for the Colorado Watershed Assembly PEPO grant. Roundtable members agreed to take up formal action later in the agenda with the formal grant requests.

Approval of Agenda: (Sean Chambers - 5 min.)
 It was moved to approve the agenda with a change of the PEPO Committee presenting at the beginning of the meeting and removing items 3 and 4 under section 6 of the agenda. Approved by acclamation.

## Approval of <u>SPBRT Meeting Summary May 14, 2024</u> (Sean Chambers - 2 min.) It was moved by Scott Griebling to approve the May 14, 2024, SPBRT Meeting Summary as presented, and it was seconded by Kirk Vincent. The motion carried.

4. Public Comment (3 min.) Jake Nemmers with Senator Hickenlooper's Office provided an update. They will be visiting and reviewing the damage from the recent hailstorm and discussing an approach to address. U.S. Senators John Hickenlooper, Cynthia Lummis, and Ron Wyden introduced two bipartisan bills to extend existing programs to continue water management programs and address long-term drought in the West. The <u>Drought Preparedness Act</u> and the <u>Water Data Improvement Act</u> would reauthorize current programs managed by the U.S. Department of Interior (DOI) and the U.S. Geological Survey (USGS) to help secure water infrastructure, prepare drought contingency plans, and improve water monitoring. Companion legislation has been <u>introduced</u> in the House of Representatives by Representative Joe Neguse. The *Drought Preparedness* 

Act passed the House and the Water Data Improvement Act has passed out of the House Committee on Natural Resources. Sen. Bennet sits on the Ag Committee, and Hickenlooper's office works closely with them to communicate priorities and concerns from communities. Please feel free to contact Jake if there is anything you'd like him to relay to their legislative team. Interest in the Farm Bill was conveyed. Cory Deangeles announced that the vacant Deputy State Engineer office was filled by John Hunyadi.

## 5. WSRF (Garrett Varra - 10 min.)

1. WSRF SPBRT Funds and CWCB Basin Account Funds updates were provided.

### 6. Colorado Water Plan Requests for Letter of Support (Garrett Varra – 30 min.)

1. 10-year strategic course for campus landscape water conservation and resiliency – Chris Bowers, University of Northern Colorado - A presentation was provided, and it was recorded. Questions were fielded. The WSRF Committee members who were able to review this request noted a need for more information on scope and funding, but believed the project to be inline with the South Platte BIP and therefore recommend approving a letter of support. The committee noted that although it is considered a large request and there is no budget information for consideration. There was discussion on the CWP application process and timing for applicants. A suggestion was made to make a statement in the Letter of Support that the recommendation was made without a budget review and is based on approval of the concept.

A motion was made by Lynda James to provide a Letter of Support for the 10-year strategic course for campus landscape water conservation and resiliency project to include a comment that the recommendation was made without a budget review and is based on approval of the concept and was seconded by Scott Griebling. The motion carried with one dissent by Bruce Gerk and one abstention by Sean Chambers. The no vote was registered with concern for the lack of details on scope, budget, and matching funds.

Town of Berthoud Water Utilities – Marie Mitchell, Town of Berthoud and Courtney Black, INTERA - A
presentation was provided, and it was recorded. The WSRF Committee recommends approving a
letter of support.

A motion was made by Garrett Varra to provide a Letter of Support for the Town of Berthoud Water Utilities project and was seconded by Scott Griebling. The motion carried.

- 7. SPBRT Recorder Position Opening (Sean Chambers) (10 min.) Diane Kielty is stepping down as the SPBRT Recorder. The vacancy needs to be filled. This is an opportunity for someone to get to know the SPBRT and learn about the water world. The job description will be developed by Sean Chambers and Jeff Rodriguez and will be distributed to SPBRT members to share with your networks.

There will be updates on the Shoshone Water Right Preserve, Colorado River, and a Legislative Session Recap.

  - 1051 data is due June 30<sup>th</sup>. Given the added complexity in the requirements there can be a 1year grace period granted upon request.

The Federal Technical Assistance and Local Capacity Grants and Wildfire Ready Watershed Grants are open on a rolling basis.
