ORDER AND DECREE ESTABLISHING GROUNDWATER MANAGEMENT SUBDISTRICT OF THE TRINCHERA WATER CONSERVANCY DISTRICT		

THIS MATTER came before the Court on the 9<sup>th</sup> day of May, 2008, pursuant to a Petition for the Organization of the Groundwater Management Subdistrict of the Trinchera Water Conservancy District. The Petitioner appeared through its Secretary Jane Devine and its attorney Erich Schwiesow. The Court received evidence and listened to the arguments of counsel. The court hereby FINDS and CONCLUDES:

1. No protest to the organization of the Groundwater Management Subdistrict of the Trinchera Water Conservancy District has been filed.
2. This Court has jurisdiction over the organization of the Subdistrict, which is situated wholly within Costilla County, Colorado, pursuant to the provisions of C.R.S. § 37-45-108.
3. The total assessed value is \$428,087.00.
4. All other statements of the Petition are true.
5. The Petition has been signed and presented in conformity with the provisions of Title 37 Article 45.
6. Based on the comparison of the list of signatories of the Petition to the list of owners of irrigated land in the proposed Subdistrict prepared pursuant to the provisions of C.R.S. § 37-45-112, more than 50% of the owners of irrigated land to be included within the District have petitioned this Court for its organization as required by C.R.S. § 37-45-109(2).
7. Based on the testimony of Petitioner's witnesses, the landowners supporting organization own more than 50% of the irrigated land in the proposed Subdistrict and more than 50% of the aggregate valuation for assessment of the land in the proposed Subdistrict.

8. As a result, and in accordance with C.R.S. §§ 37-45-120 and 37-45-112(7), this Court decrees that the Groundwater Management Subdistrict of the Trinchera Water Conservancy District is hereby organized and shall be known as the Groundwater Management Subdistrict of the Trinchera Water Conservancy District. The office and principal place of business of the Subdistrict shall be located jointly with the Trinchera Water Conservancy District in Blanca, Colorado.

9. The Subdistrict shall consist of all irrigated lands within the boundaries of the Trinchera Water Conservancy District described as follows:

ALL OF COSTILLA COUNTY LOCATED NORTH OF THE FOLLOWING LINE:  
Beginning at the point of intersection of the Rio Grande River and the South line of Section 11 in Township 32 South, Range 75 West of the 6<sup>th</sup> Principal Meridian; thence East to the Southwest corner of Section 12 in Township 32 South, Range 71 West of the 6<sup>th</sup> Principal Meridian; thence North to the Northwest corner of Section 12; thence East to the Southwest corner of Section 2, Township 32 South, Range 70 West of the 6<sup>th</sup> Principal Meridian; thence Northeasterly along the top ridge dividing the TRINCHERA DRAINAGE BASIN and the CULEBRA DRAINAGE BASIN to TRINCHERA PEAK.

In particular, the Subdistrict shall consist of the lands described on the attached Schedule A.

10. Pursuant to the request of the Petition and the provision of C.R.S. §§ 37-45-120 and 37-45-122(2)(a)(I), the Subdistrict's initial mill levy is set at 1.5 mills.

11. The Clerk of the Court shall transmit to the Division of Local Government in the Department of Local Affairs and to the County Clerk and Recorder of Costilla County, copies of this Order and Decree incorporating the Subdistrict.
