Resource Central's program maximizes the impact of conservation efforts across Colorado by consolidating funding and resources through a single grant, creating economies of scale that allow us to reach communities statewide. By partnering directly with water providers, we enable them to offer comprehensive water-saving programs that reach more residents and cover a larger area than they could independently. Our model unifies conservation efforts across providers, promoting water-saving practices and fostering a lasting shift toward sustainable landscape management that aligns with Colorado's long-term conservation goals. Our proposed grant addresses a critical need by streamlining turf replacement and irrigation upgrades for non-residential properties, such as HOAs, business parks, and public spaces. These properties often maintain large, high-water-use landscapes primarily for aesthetics, placing a significant demand on local

water supplies. By targeting non-residential sites, we maximize water savings where they're needed most, as these properties typically offer the greatest potential for significant, lasting reductions in water use. Through detailed assessments, landscape conversions, and irrigation improvements, our program empowers property managers and decision-makers to make data-driven changes, advancing statewide conservation efforts and building drought resilience across Colorado.
