This program would make a landscape transformation project extremely affordable if it involved transition to native grass areas.

Equity Considerations

How is equity included into and/or supported outside of your turf replacement program when it comes to your communities water conservation efforts?

Colorado Springs Utilities has multiple programs that support residential and business customers, particularly in lower income areas as follows: 1) free bathroom fixtures for any government or NGOs that provide temporary or affordable housing, 2) multi-family bathroom retrofit program--free--for affordable housing (and includes LED bulbs, aerators for kitchen and all leak repairs, 3) small business efficiency program offers free water and energy fixture upgrades and leak repairs and is target marketed to low income areas, 4) arbor day tree program (giveaway) that

ensures half of the 300 trees distributed each year are offered to low canopy area customers, 5) translation of all financial help flyers and rebate programs into Spanish and distribution to public areas in town. (And in 2025 hope to receive grant to offer toilet retrofits to all low income customers who choose to plant a tree in their yard as part of our City Forestry's grant to improve the urban forest and build canopy in key, low-income/low-canopy areas.

Colorado Springs Utilities desires to advance landscape conversions from turf grass to water wise landscapes that can thrive with one day/week watering (8-12" of annual, supplemental irrigation). This proposal narrows the solutions to water wise landscapes that will be cost effective, aesthetically appealing and resilient for our climate. Colorado Springs Utilities understands that it is important to offer financial incentives alongside professional landscape knowledge and expertise to compel government, education and commercial properties to engage in such projects. Springs Utilities also understands that all parties (customers, landscape contractors, water providers, landscape architects) need to build knowledge in water wise best practices and build learning capacity through projects that we anticipate will offer resilient alternatives for the urban, built landscape in our climate. We have identified two areas of focus: a) ongoing testing of native grasses that have been installed in a variety of settings and still need more examples to confirm best practices and build capacity; and b) testing of water wise solutions for hard to landscape areas (and where turf grass will no longer be allowed due to the passage of SB24-005).
