Date: December 5, 2024

The Colorado Water Conservation Board (CWCB) staff has drafted proposed revisions to Rule 6k of the Rules Concerning Colorado's Instream Flow and Natural Lake Level Program ("ISF Rules"). The revisions to the ISF Rules will address the rulemaking requirements for Section 2 of SB24-197, codified at 37-83-105(1), C.R.S.
