## **Summary Minutes and Record of Decisions**

### **September 18, 2024, Board Meeting**

A regular meeting of the Colorado Water Conservation Board (CWCB) convened at the SkiHi Complex in Monte Vista and virtually on zoom. The meeting was called to order by Chair Nathan Coombs. 10 voting members were present at the call to order, so a quorum was present (at least 6 required).
