The meeting was called to order at 3:06 p.m. by Chairperson Wendell Koontz.

Roll Call/Introductions

After roll call a quorum was declared to be present.

Agenda Approval

There were no changes to the Agenda.

Approval of Minutes from the September 16, 2024 Meeting

Bill Nesbitt moved to approve the Minutes of the September 16, 2024 meeting as submitted. Jim Plumhoff seconded, and the motion passed unanimously.

Membership Election (Wendell Koontz)

b. Delta County Municipalities

Wendell Koontz was the tie breaker choosing Bill Tedrow as the Delta County Municipalities representative.

Education Committee Report (Savannah Nelson)

Savannah Nelson reported on PEPO efforts, including:

 - Update to the Gunnison Basin handbook

Grant Review Committee Report (Kathleen Curry)

Kathleen Curry presented the following items:

a. Terror Creek Ditch Company - Colorado Ag Water Alliance

This project is for \$50,000 from the Basin and \$205,000 from State funds for rehabilitation of the Terror Ditch diversion and 1.1 mile of pipe across a steep slide area.

Allen Distel moved to approve the screening committee recommendation for \$50,000 from Basin funds and \$205,000 from State funds for the Terror Creek Ditch Company rehabilitation and piping project. Bill Nesbitt seconded and the motion carried. Bruce Bair recused.

Allen Distel amended his motion to approve \$50,000 from Basin funds and \$215,000 from State funds for the Terror Creek Ditch Company rehabilitation and piping project. Mark Roeber seconded and the motion carried.

b. Grand Valley River Corridor Initiative, Letter of Support – R. Lloyd

Bill Nesbitt moved the GBRT send the letter of support. Steve Pope seconded and the motion carried unanimously.

c. Deutch Domestic Water Company, Inc (DDWC), Update to Previous Letter of Support – R. Hobbs

Steve Pope moved to update and send the letter of support. Bobbi Daniel seconded and the motion carried unanimously.

d. HEART Force Drought Resilience Game, Letter of Support – K. Schloesser

Neal Schwieterman moved to provide a letter of support. Allen Distel seconded, and the motion carried unanimously.

e. Keira Johnson, PhD Student at Oregon State University, Request for Letter of Collaboration

Bill Nesbitt moved to provide a letter of collaboration for Keira Johnson. John McClow seconded, and the motion carried unanimously. Bill Nesbitt requested Keira to report back to the Roundtable.

Colorado River Zebra Mussel Update (Robert Sakata and Robert Walters)

Robert Walters, Invasive Species Manager, DOW, gave a presentation on Zebra Mussels in the Colorado River. He discussed plans for eradication, containment and prevention.

Interbasin Compact Committee Report (J. Fagan, M. Roeber)

Joanne Fagan reported the committee has not met since the last GBRT meeting. The committee will meet again in February 2025. Anyone with comments on No and Low Regrets should get those to Joanne.

Legislative Update (K. Curry)

Kathleen Curry reported on the following legislative items:

- ➤ Water Resources and Ag Review Committee is pushing forward 2 bills:
 - Back-flow prevention inspection bill
 - Bill to establish a task force to look at severance tax and water funding
- ➤ General assembly convenes on January 8. There are 22 new house members.
- ➤ DNR budget is on the next Joint Budget Committee agenda.
- > Presentation on December 2 regarding Severance tax.

Other Business

Jeff Rodriguez has provided an abbreviated BIP projects list, and Wendell would like to dedicate 30-45 minutes at the next 3 roundtable meetings to update the list and get it back to CWCB by July 2025.

GBRT members discussed moving meetings back to Montrose. Some members offered to look into meeting rooms in Montrose, and Jeff Rodriguez mentioned funds are available. This will be a topic for January.
