Gracy Goodwin discussed the recent Needs Assessment Committee meeting and the applicants requesting grants. One of the applicants Stacy Sober will do a presentation during our regular session today. Jonathan Paklaian had a presentation, but will hold off now. The issue Gracy iterated was available funding for upcoming projects. Jeff Rodriguez stated there was \$628K still available. According to Gracy the water quality issue does not qualify under CWCB guidelines, but is important and of concern so some of our Basin only funds might be able to go there. Terry suggested that water quality may go under the CDPHE because these funds are for protecting watershed and water quality. Lonnie Brown pointed out that following the Spring Creek Fire funds were directed at private lands for mitigation, but the US Forest lands higher up had none. Of

concern is funding projects without specific tasks, but possible results from a perceived event, such as, possible future fires. Funding these projects was discussed as to which is the best time to apply and what calendar year would it be available.
