Summary Minutes and Record of Decisions

March 19 & 20, 2025 Board Meeting

A regular meeting of the Colorado Water Conservation Board (CWCB) convened at the Doubletree Hotel in Greeley and virtually on zoom. The meeting was called to order by Chair Nathan Coombs. 10 voting members were present at the call to order, so a quorum was present (at least 6 required). Voting members present were: Greg Felt, Brad Wind, Taylor Hawes, Barbara Vasquez, Mike Camblin, Lorelei Cloud, John McClow, Greg Johnson, and Nathan Coombs, and ex-officio voting member Dan Gibbs, Executive Director of the Department of Natural Resources. Non-voting ex officio members present or represented were: Scott Steinbrecher, Attorney General's Office; Matt Nicholl, Colorado Parks and Wildlife; Robert Sakata, Department of Agriculture; Jason Ullmann, State Engineer, Becky Mitchell, IBCC Director, and Lauren Ris, Colorado Water Conservation Board Director.
