 - i. El Paso County Muni Rep Jenny Bishop
 There was an introduction. The MRT approved Jenny Bishop.
 - ii. Representation Adjustments Discussion Membership term limitations will be discussed in June. A comparison will be made between the Colorado for the 21st Century Act, CWCB Guidelines, and the MRT Bylaws to bring the MRT By-laws in alignment. At this time, the only open seat will be the Recreation At-Large.

6. WSRF Committee (Sam Calkins) (10 min.)

- 2. WSRF 2025 Cycle 1 Applications Committee Recommendations Final Approval from MRT
 - 2050 Comprehensive Douglas County Water Plan Douglas County has split the
 grant into two parts. They asked for \$120,000 from MRT. The other half will be
 requested via a Water Plan grant. CWCB is working with Douglas County to ensure
 these are separate grants.
 - <u>CMWC ET Study and Floatovoltaic Design</u> They have had further discussions with the photovoltaic company, and it is ready to go forward. They have been working with NREL.
 - Youth Development Water Education and the Colorado Water Plan After this year the program will look at a Water Plan grant for the final three years of the program.

All three projects were approved to advance to submit a full application to the WSRF program.

8. ASO Flight Results (Taylor Winchell) (15 min.)

A presentation was provided. Slides made comparisons in year-to-year snowpack as well as upper and lower basin comparisons. The data has been useful and has changed management decisions.

1. Jenna Battson - 5 min. – This was the 15th dryest April in 130 years in Colorado. There is a water conditions webinar. The next one is May 20th from 9:30 am – 11:00 am. 2. Amy Ostdiek - 5 min.

A presentation was provided on post-2026 operations of Lake Powell and Mead as they relate to changes in the Federal landscape and actions going forward. They are meeting regularly with the other basin states to come to a consensus. Supply versus demand operations is the Colorado goal.

The Federal Authorities alternatives is the alternative that could be implemented immediately. The hybrid alternatives have more flexibility but would require additional agreements or federal approval to initiate.

Media statement excerpt on Pillars document:

The "Essential Pillars for the Post-2026 Colorado River Guidelines" include areas of shared interest with the Upper Division States Alternative and Commissioner Mitchell's Post-2026 <u>negotiation priorities</u>. The Upper Division States support sustainable operations; storage recovery; cooperation with Mexico and the Basin's Tribal Nations; and compensation for the Tribes' forbearance of water rights.

However, the pillars overlook the Upper Basin's water rights administration, which reduces uses in the Upper Basin and puts water into the system every year. These mandatory and uncompensated cuts represent how Upper Basin water managers respond to the physical and legal availability of water each year. Colorado water users do not enjoy a guaranteed delivery of the full amount of their water rights each year. Reductions average 600,000 acrefeet in Colorado alone. Estimates over the last 24 years in the Upper Division States average 1.2-1.3 MAF per year.

1. PEPO Committee (C. Davenhill) (10 min.) (4/3/2025 Meeting Summary) A subcommittee meeting was held on May 1st to solicit guidance with intention of submitting a grant application this coming year. An outline was developed and is in the PEPO meeting agenda. An overview of the four categories of the PEPO plan was provided. There was a statewide PEPO coordinator meeting on May 2nd. MRT PEPO is waiting for additional guidance based on the outcome of the statewide meeting. There was encouragement to expand efforts with local communities that are not water professionals. The message is "There is a Colorado Water Plan." A final draft PEPO application will be shared with MRT next week.

A motion was made by Heather to provide a Letter of Support for the Colorado Watershed Assembly to submit a PEPO application. It was seconded by Devon Buckels. The motion carried.
