Dear Ms. Bralish-

I am writing you to express the following concerns about the proposed Shoshone water rights in stream flow purchase:

\$99 million is an excessive amount to pay Excel Energy for an ISF that by definition already returns to the Colorado River. Excel has taken advantage of growing fears of the western slope water community about declining water levels and Front Range diversions to extort a high price that sets a bad precedent for future ISF transactions. I urge you to think about the price per cubic foot for this transaction and what impact that will have on the cost to any future ISFs to protect Colorado River flows.

As you know, federal funding has not been secured and it is unclear to me if all other funding can be counted on given state and federal budget reductions. Is this action before you simply premature?

Finally, it appears that negotiations on future Colorado River allocations may be moving away from the historical "compact call" demand model to a new supply-based model that may require releases from the upper basin if flows drop below some recent historical average. What might be the diminished value of this ISF in such a situation? Won't ISFs have to take a proportionate reduction?

I urge you to take your time, gather more information and carefully deliberate on the future consequences of any decision the board may make.

Re: Public Comment - Support for Instream Flow Acquisition of the Shoshone Water Rights

Dear Members of the Colorado Water Conservation Board:

With this letter, the West Divide Water Conservancy District board of directors shares its unanimous support for the proposed acquisition of the Shoshone Water Rights to the state's Instream Flow Program. We urge the CWCB to accept this once-in-a-lifetime, stabilizing proposal to permanently preserve the historical flow regime of the mainstem of the Colorado River on which water users and the environment on both sides of the Continental Divide depend. West Divide believes the Shoshone water rights will preserve and improve the natural environment of the Shoshone Reach to a reasonable degree and therefore meets the letter and spirit of the instream flow acquisition statute.

The citizens of the West Divide District in central Garfield County voted to create the district in 1964. Today, more than 500 water contract customers rely on our augmentation plans for domestic and irrigation water. Those augmentation plans in turn rely in significant part of the continuous flows in the Colorado River assured by the senior Shoshone water rights.

Additionally, the Shoshone water rights are critical to maintaining compact compliance, fisheries, riparian habitats, and flows for downstream users including the recovery efforts of the four listed fish species. As the Board knows, the Recovery Program is predicated in large part on the flows resulting from continued exercise of the Shoshone water rights. Continued success of the Recovery Program is critical to water users on both sides of the state.
