The Colorado River District ("River District") and Public Service Company ("PSCo") submit this Revised Request re: Allocation of Time and Order of Presentation. The River District is authorized to state that the West Slope Proponents and other Supporting Groups, identified below, consent to the following time allocations and order of presentations:

- 1. CWCB Staff: 90 minutes, inclusive of rebuttal.
- 2. PSCo: 20 minutes, inclusive of rebuttal.
- 3. The River District, West Slope Proponents, and other Supporting Groups, collectively: 270 minutes, inclusive of rebuttal.
- 4. For purposes of time allocation and presentation proposal, the West Slope Proponents and Supporting Groups consist of the Headwaters Parties, the Garfield County Entities, KWA, the Grand Valley Entities, WRA et al./TU, AW/CROA, and SWCD.
- 5. The revised combined time allocation for the River District, West Slope Proponents, and the Supporting Groups represents a 30% reduction from their initial time requests.
- 6. In the interest of fairness, we propose that the Hearing Officer impose a corresponding reduction of 30% on the time allocation for the opposing parties.
