The proposed water activity, by Colorado City Metropolitan District (CCMD), includes engineering design that will address critical rehabilitation of Lake Beckwith dam that will ensure compliance with the Colorado Office of State Engineer (SEO) Lake Beckwith Dam Safety Compliance Plan dated October 19, 2021. Engineering design shall also include widening of dam embankment to accommodate a future 10-ft dam raise and storage capacity increase.

Lake Beckwith is the main municipal water storage facility for CCMD. Lake Beckwith is also a community and regional focal point for recreational uses such as jogging, biking, kayaking, paddle boarding, fishing, community events, bird watching, etc.

Engineering design for dam improvements generally include: leveling and widening the dam embankment, internal drains and filters in the dam embankment and toe, seepage cutoff trench through foundation soil, and new siphon outlet works.

The proposed engineering design will accommodate a future 10-ft dam raise and increase in reservoir storage that would demonstrate diligence to the water court toward making currently held CCMD conditional storage rights absolute.

The requested WSRF funds will be used for development of SEO approved engineering designs, construction plans and specifications. Engineering design will be completed by RJH Consultants.

CCMD is currently under a one (1) foot storage restriction, which equates to 70 acre-feet of reservoir storage volume. The necessary rehabilitation will alleviate the 70 acre-feet loss and preserve the 1033 acre-feet of water storage.
