Metro Roundtable Business Meeting

- 1. Welcome/Introductions (1 min.)
- 2. Approval of August 14, 2025, Meeting Summary (1 min.)
 The August 14, 2025, Meeting Summary was approved by affirmation.
- 3. Agenda: additions or changes (1 min.)

Addition to the WSRF projects for approval to move forward the Automated Headgate for the Ag Ditch Company, Anthony Cline, and the South Metro Children's Water Festival, Angie Grunder. The agenda as revised was approved by affirmation.

4. Public Comment (5 min.)

Robert Sakata commented on the Water Education Colorado's President's Reception event to recognize the great work they do.

- 5. WSRF Committee (Sam Calkins & Heather Justus) (25 min.)
 - 1. WSRF Balance Summary (<u>WSRF Budget Summary 4/25/2025</u>) \$428,000 for this cycle. This cycle request amount is under review. There is funding available for all projects under consideration for this cycle. The Lincoln Cares Project funded in a past cycle did not get submitted. The \$15,000 from this cancelled project will be returned to the fund. The CWCB deadline is December 1st.
 - 2. Application period was closed on Friday, September 5th
 - i. <u>Dust-on-Snow Data Collection & Cosmic Ray Evaluation</u>, Center for Snow and Avalanche Studies, Ella Brup

 The group is requesting funding for a two phase project. A presentation was

The group is requesting funding for a two-phase project. A presentation was provided. Part of the funding would go to support data sharing. Project sites are high elevation, and the data gathered is looking for regional effects of topography. The project focuses primarily on the west slope where much of the dust originates. Funding would also go toward a feasibility assessment of a Cosmic Ray Neutron Rover as an emerging snow monitoring technology for improved water management. This is a 4-year project. The project proponents are approaching all RTs (except for the North Platte). The request from each RT is \$30,000, which in total will cover the full 4-years.

MRT approved the advancement of the Dust-on-Snow Data Collection and Cosmic Ray Evaluation project.

ii. Confluence of River Action (CNS), Confluence Colorado, Shane Wright

The project proponent was not present. Sam Calkins will reach out to the applicant.

iii. Phased Water Resource Development for Farm Incubator Program – 35 Acres, Bennett, Colorado, Ag & Food Lab, Eileen O'Rourke

The project focuses on water-smart agriculture for small farms. A presentation was provided. This is a 501(c)3 nonprofit farm "incubator" laboratory. The Lab practices regenerative agriculture and would like to expand the acreage and improve water delivery and access to the lands available. This would amount to 6-7 acres to be watered with drip irrigation using a three-phased approach. A well is already there with water rights, but they are not able to pull water to the watering sites. Phase I is assessment and design. Phase II is well development. Phase III is installation of irrigation and storage. It was suggested that the timeline should be reconsidered to build in time for contracting. It was strongly suggested to have the budget largely developed prior to submission.

MRT approved the advancement of the Phased Water Resource Development for Farm Incubator Program project.

iv. Automated Headgate for the Ag Ditch & Reservoir Company, Anthony Cline

A presentation was provided. The Company manages 23 miles of delivery ditch running from Clear Creek to Lakewood. A shift in clients from Ag to Municipal has equated to shifts in priorities. The Company is reviewing the system to make upgrades. A larger goal is developing a long-term/20-year plan for a multi-purpose water supply, water efficiency, also considering environment and recreation. The project's full cost is \$100,000. The Ag Ditch cost share would be \$50,000. This would be a replacement and upgrade of an automated headgate.

MRT approved the advancement of the Automated Headgate for the Ag Ditch Company project.

v. South Metro Children's Water Festival, Angie Grunder.

The South Metro Water Supply Authority is working to make this an annual event with a sustainable funding source. A presentation was provided. The event is geared toward families and children. There are crafts, games, and hands-on activities. They have a tentative date for the next festival of June 17th, 2026, to be hosted at Highlands Ranch. The event would be funded by hosts to allow for no charge to community members, consultants, organizations, and Districts. The request is \$60,000 with a \$15,000 match for 3-years of festivals. This equates to \$20,000 per year with a \$5,000 match per year. It was suggested to quantify outcomes with measurables for funder consideration.

MRT approved the advancement of the South Metro Children's Water Festival project.
