Procedural Order for Presentations and Deliberations

To further clarify the October 14th procedural order and November 14th modification, this order outlines the schedule of events for Shoshone matters:

- 1. Public comment: <u>Maximum of 3 minutes each.</u> A warning will be given at one minute remaining. The Board will not ask questions of the public commenters.
- 2. Directives Presentations (the Board may ask questions of each presenter after the presentation. Board questions will not count against presentation time):
 - a. Staff and CRD jointly present on the directives: 20 minutes
 - b. Front Range entities (Aurora, Denver, CSU, Homestake Partners, and Northern) jointly response to Staff and CRD's directives presentation: <u>15 minutes.</u>
 - c. Additional responses to directives: 5 minutes each.
 - i. Glenwood Springs (COGS) + City of Rifle (Rifle)
 - ii. Mesa County (Mesa)
 - iii. Kobe Water Authority (KWA)
 - iv. WRA et al
 - v. GV Entities: (Clifton Water District, Grand Valley Water Users Association, Mesa County Irrigation District, Orchard Mesa District, Palisade Irrigation District, and Ute Water Conservancy District
 - vi. Headwaters Parties: (Northwest Colorado Council of Governments Water Quality / Quantity Committee (QQ); Grand County; Summit County; Eagle County; Eagle River Water and Sanitation District; Upper Eagle Regional Water Authority; Eagle Park Reservoir Company; Town of Vail; Town of Eagle; Town of Basalt; Roaring Fork Conservancy; Eagle River Coalition; and Middle Park Water Conservancy District
 - vii. Garfield County (Garfield)
 - viii. Clinton Ditch & Reservoir Company (CD&RC)

 - c. Front Range Entities (25 minutes)
 - d. SM Wise (5 min)
 - e. Pitkin (5 min)
- 5. The Board will close the record and deliberate. No parties may be recalled for questions.
