GENERAL INSPECTION TOPICS

OBSERVATIONS

This was an inspection conducted by Tom Kaldenbach of DRMS. The operator was represented by Wayne Brantley of Pioneer Sand Co. James McCarthy, representing the City of Arvada, also was along on the inspection. DRMS recently received a Succession of Operator application to transfer the site to City of Arvada, the landowner. The ground was dry and the weather was clear.

Signs and Markers

A mine i.d. sign was properly displayed at the mine entrance gate. The affected area was marked by fences.

Hydrologic Balance

Ditches along roads on the site were in good shape.

There were no signs of excessive erosion on the site.

Backfilling and Grading

The site appeared during the inspection much as it does in the Google Earth image from October 8, 2012, shown below. There are several material stockpiles on the site, mainly in the central and western portion of the permit area. Product stockpiles for sales are located near the office near the center of the site. City of Arvada plans to use stockpiles on the east side of the site for filling in low areas there for mosquito control. Other stockpiles will graded out and then the site will be revegetated. During the inspection, the need for a Technical Revision was discussed that will be submitted after the permit is transferred to City of Arvada. The Technical Revision will inventory stockpiles that need regrading.

Regrading was in progress on the embankment of a sediment control pond.



On-Site Facilities

Fuel was stored in secondary containment structures.

General Mine Plan Compliance

The operation appeared to be following the mine plan with mining nearly complete. The representative from City of Arvada explained that no mining will be conducted after the site is transferred to them, and most reclamation will be completed in spring of 2014.

There were no signs of off-site damage around the perimeter of the site.

Revegetation

City of Arvada is managing the weed control plan on the site. Other than some areas of thistle on the east side of the site, no weed problems were found. The thistle will be eradicated through the on-going weed control effort.

Financial Warranty (Reclamation Bond)

The operator had financial warranty in the amount of \$577,355 on deposit with the State at the time of the inspection. As a government entity the successor operator, City of Arvada, will not be required to provide financial warranty.
