NOTICE OF PROPOSED DECISION

The Colorado Division of Reclamation, Mining and Safety proposes to Approve Technical Revision Application No. 55 (TR-55) for the Bowie No. 1 Mine (Permit No. C-1981-038), submitted by Bowie Resources, LLC. Bowie Resources, LLC is requesting removal of the requirement to monitor water levels and quality at well B-4. The well was monitored from 1981 through 2012, until it was damaged by maintenance equipment, and was used to determine static water levels for the purpose of monitoring geotechnical stability.

The Bowie No. 1 Mine is a/an Underground coal mine located in Delta County/Counties, approximately 3 miles N of Paonia. Coal interest is Federal and private, and the surface affected is Federal and private land. The permit area encompasses approximately 5,431.00 acres.

This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 34-33-101, *et seq.*, C.R.S., and the regulations promulgated thereunder.
