Cotter Corporation (N.S.L.), 7800 East Dorado Place, suite 210, Greenwood Village, CO 80111, 720-554-6200, has filed an application for the partial release of **Financial Warranty with the State of Colorado, Division of Reclamation, Mining and Safety under the provisions of the Colorado Mine Land Reclamation Act**. The mine is known as the Schwartzwalder Mine, and is located at or near Section 25, TS2, R71W, 6th PM, Jefferson County, Colorado, approximately five miles north of Golden.

The amount of the release application is \$3,092,729.24 for work completed between July 2010 and May 2013; consisting of performing interim groundwater treatment at sump 1, the construction of sump 5, 8, 9 and 10 at the mine, the purchase and operation of the water treatment system through May 2013, Monitor wells installed and the installation of the 18 inch creek diversion pipeline and cutoff wall.
