## **OBSERVATIONS**

This inspection was conducted as part of the monitoring program established by the Division of Reclamation Mining and Safety. The 32 Road Pit is located at 32 Road and C½ Road, east of Grand Junction, Colorado. Royce Clements of Parkerson Construction, Inc. accompanied the inspector during the inspection.

The inspection was to observe the amount of vegetation established on the topsoil stock piles and determine if the previously ordered corrective action of vegetating the topsoil stockpiles was necessary. The vegetation on topsoil stockpiles located along the eastern border of the permit consisted primarily of annual weeds that were abundant due to the higher than average amount of precipitation. The topsoil stockpiles located along the southern border of the permit area had perennial grasses along with shrubs. The operator was instructed to seed the areas that were bare or covered with annual weeds.
