OBSERVATIONS

This inspection was conducted as part of the normal inspection program conducted by the Division of Reclamation, Mining and Safety (DRMS). Paul Daggett with the BLM White River Field Office and Flo Vuelvas of Shell Frontier Oil and Gas Inc. were present during the inspection

The site was inactive during the inspection. The operator indicated that reclamation of the site would likely begin within the next year.

The overall appearance of all sites observed was organized and free of unnecessary debris.

No evidence of erosion or off site damage from erosion was noted.

No significant infestations of noxious or other problematic weeds were observed at any of the areas visited during the inspection.
