On behalf of Tomichi Resources, LLC (TR), Gault Group, LLC. (GGL) formally requests from the Colorado Division of Reclamation Mining and Safety (DRMS) full bond relase/return of \$41,000.00 for reclamation permit number P-2011-18, and final forfeiture of this permit.

During the 2012 field season, TR drilled on hole locations P-01, P-03, P-05, and P- 10, representing four of the ten drill locations authorized by the aforementioned reclamation permit (see drill hole location information below). Sufficient information was gathered during this abbreviated program to confirm the historical drill data and allow planning of further investigations.
