Notice to Interested Persons to the Animas Glacier Gravel (AGG) Permit Revision

RE: Comments for Technical Revision to Oldcastle SW Group, Inc. dba Four Corners Materials, Animas Glacier Gravel (AGG), Permit No. M-2011-028

Dear Interested Person:

The Colorado Division of Reclamation, Mining, and Safety (DRMS) received the necessary technical revision to the permit for Animas Glacier Gravel (AGG), required prior to commencement to mining at the site.

During the review of the original 112c permit application, you expressed concerns related to potential discharge from the site. The permit application was approved with the understanding that a technical revision, addressing drainage issues, would be submitted by the operator, and the individuals who had concerns during the original application process would have the opportunity to comment on the revision.

A copy of the submitted revision was forwarded via e-mail to the interested parties last week. The Division's staff engineer will be conducting a review of the materials submitted.


