**Re: Foidel Creek Mine (Permit No. C-1982-056)
Technical Revision No. 83 (TR-83)
Mine Plan Modification for Wolf Creek Reserve Initial Development.**

Dear Ms. Maiolo:

The Division of Reclamation, Mining and Safety hereby issues notice, in accordance with Title 34, Article 33, Section 116, Paragraph 4, of the Colorado Revised Statutes, that on February 6, 2014 an application to revise coal mining operations at the Foidel Creek Mine was considered complete for the purposes of filing. The revision was submitted by Twentymile Coal, LLC. All review and comment periods as provided in the Act and the Regulations initiate from this date of filing.

Technical Revision No. 83 (TR-83) requests to modify Twentymile Coal LLC's approved mine plans to include initial development for the Wolf Creek Coal Seam Reserve. Initial development will include development and placement of long-term support for a 3-entry rock slope access, development of up to six sets of gate-roads and bleeder entries, and related ancillary activities including, underground dewatering activities and the extension of mine ventilation and support systems.

The Underground coal mining operation is on land located approximately 23 miles Southwest of Steamboat Springs, Colorado. The permit area is further described as follows:

In portions of Sections 7, 8, 9, T4N, R86W; Sections 32 and 33, T6N, R86W; Sections 23, 24, 25, 26, 27, 34, 35 and 36 in T5N, R87W; and all of T5N, R86W with the exception of Sections 34, 35, and 36. (move to Quad: Cow Creek, Dunckley, Milner, Mount Harris, and Oak Creek)

The above-mentioned tracts of land are shown on the following USGS 7.5 minute Quadrangle map(s): Rattlesnake Butte.

The applicant is required to publish notice in a local newspaper that this application has been deemed complete. At the time of publication of this notice, the applicant is additionally required to place a copy of this application at the Routt County Clerk and Recorder, 136 6th Street, Steamboat Springs, CO 80477, and at the Division office. For additional information or to provide written

In order for us to comply with regulatory time frames, we request that comments be submitted within fifteen (15) days of this letter. If no comments are received by then, we will proceed on the assumption that you have no concerns with, or objections to, the applicant's proposal.
