## **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (Division). The Meeker Pit is located approximately 4 miles east of Meeker, Colorado at 3251 County Road 4. The site is a 112c construction materials operation that includes 78.80 acres with a maximum allowed disturbance of 50 acres. Katie Conrado of Meeker Sand & Gravel was present during the inspection.

The required mine identification sign and boundary markers were in place and in compliance with Rule 3.1.12. The permit boundary markers were comprised of fences and fence posts around the entire perimeter of the mine.

The fuel tank observed at the site was placed in adequate secondary containment in the event of a fuel leak.

Stockpiles of various construction materials were observed at various locations around the site. No active mining was occurring during the inspection due to the inclement weather. The site was free of any uncessary debris and appeared to be well kept.

A required routine reclamation cost update will be conducted and sent under separate cover.
