## **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (Division). The White River City Pit is located approximately 17 miles west of Meeker, Colorado. The site is a 112c construction materials operation that includes 92.74 acres with a maximum allowed disturbance of 81.95 acres. Tony Connell and Darrell Aplonolp representing Connell Resources, Inc. were present during the inspection.

The required mine identification sign and boundary markers were in place and in compliance with Rule 3.1.12. The permit boundary markers were comprised of fences and fence posts around the entire perimeter of the mine.

Stockpiles of various construction materials were observed at the site. No active mining was occurring during the inspection due to the inclement weather. The site was free of any uncessary debris and appeared to be well kept.

Topsoil stockpiles were observed in the approved locations. It appeared that an adequate amount of topsoil was stockpiled to complete the approved reclamation.

All fuel on site was stored in double lined tanks.

No problems or possible violations were observed during the inspection.

A required routine reclamation cost update will be conducted and sent under separate cover.
