## NOTICE OF PROPOSED DECISION

The Colorado Division of Reclamation, Mining and Safety proposes to Approve Permit Renewal Application No. 4 (RN-4), submitted by Hayden Gulch Terminal, LLC for a coal mining permit at the Hayden Gulch Loadout (Permit No. C-1992-081). The proposed renewal will allow for continued mining and/or reclamation operations at the site.

The Hayden Gulch Loadout is a/an Loadout operation located in Routt County, approximately 2 miles Southeast of Hayden, Colorado. Coal interest is Federal, state and private, and the surface to be affected is State and private land. The permit area encompasses approximately 391.20 acres.

This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 34-33-101 *et seq.*, C.R.S., and the regulations promulgated thereunder.
