

## **EXHIBIT H WILDLIFE INFORMATION**

This exhibit contains the wildlife information for the Mine Life Extension. Information required by Exhibit H is contained in the Project Description, primarily in Section 4.7, in Volume I of this application. The Project Description describes significant wildlife resource in the permit area; and threatened, endangered, sensitive, and candidate species that may occur in the general area. In addition, discussions of wildlife protection are included in Section 5.0 Mining and Operations Management Plan, Section 6.0 Valley Leach Facility, and Section 7.0 Precious Metals Recovery Facility. Appendix 3 in Volume III contains a detailed discussion of wildlife inventories and literature reviews.

The Colorado Division of Wildlife ("DOW") has been notified by Cripple Creek & Victor Gold Mining Company of the proposed Mine Life Extension and their input has been requested. Cripple Creek & Victor Gold Mining Company met with Ms. Tanya Sharp of the DOW at the Cresson Project site on March 17, 2008 to discuss the planned changes under the Mine Life Extension and seek input from the Division of Wildlife. Cripple Creek & Victor Gold Mining Company will continue to coordinate with the DOW on the proposed project changes.

## **EXHIBIT I**

### **SOILS INFORMATION**

Information on the soils baseline conditions within the Mine Life Extension is contained in the Project Description found in Volume I of this application, specifically in Section 4.8. This section provides information on general type, thickness, and distribution of soil and suitability of salvaging material for plant growth purposes realizing that mining related activities have occurred for over 100 years in the Cripple Creek Mining District. Appendix 3 in Volume III contains a detailed report on the site soils as well as a soils map.

## **EXHIBIT J**

### **VEGETATION INFORMATION**

Information on the existing vegetation in the Mine Life Extension area is contained in Section 4.9 of the Project Description, Volume I of this application. This section provides information on vegetation types and other relevant matters realizing that mining related activities have occurred for over 100 years in the Cripple Creek Mining District. Appendix 3 in Volume III contains a detailed report on the site vegetation as well as a vegetation map.

## **EXHIBIT K CLIMATE**

Information on the climate at the site is contained in Section 4.10 of the Project Description in Volume I of this application. The climatological information has been updated to contain the most recent data from the CC&V monitoring station at the Rigi Monitoring Station located in the Vindicator Valley. For the design of the Phase 5 VLF, gaps within the climatological data were filled using climate records from the Western Regional Climate Center.

## **EXHIBIT N**

### **SOURCE OF LEGAL RIGHT TO ENTER**

Title to all of the property within the permit boundary owned by Cripple Creek & Victor Gold Mining Company is subject to the Amended and Restated Joint Venture Agreement dated effective January 1, 1991 between Pikes Peak Mining Company and Golden Cycle Gold Corporation. The original Joint Venture Agreement was dated January 30, 1976. This agreement was superseded by the Joint Venture Agreement dated August 28, 1980. Amendments to this document were executed effective December 2, 1982, April 23, 1985, May 8, 1986, and January 1, 1987. None of these Joint Venture Agreements are recorded. Title to the properties covered by the Joint Venture was formally conveyed into the Joint Venture by the conveyances listed below.

#### **B. Legal Right to Enter Property in Common**

In addition, Colorado has a special statute granting broad rights to a co-tenant of mining property. The statute specifies that any tenant in common shall have the right to "enter upon, occupy, prospect, develop and work" a mine, "in a minerlike manner, extracting, milling, and disposing of the ore from the common property without the consent of any nonworking tenant in common, subject to accounting to the nonworking tenant for his proportionate share of the net profits of such mining operations:" C.R.S. §34-44-103
