OBSERVATIONS

This pre-operation inspection was conducted in response to an Amendment application (AM-06) that the Division of Reclamation, Mining and Safety (Division/DRMS) received on March 4, 2014. The pre-operation inspection was conducted by Tyler O'Donnell, Amy Escherger, Elliott Russell, and Tom Kaldenbach of the Division. E-470 Public Highway Authority, the Operator, was represented by Neil Thomson during the inspection. The Henderson Development pit (Sandy Acres Pit) is a 42.80 acre 112 Construction Materials Reclamation Permit. The Henderson Development pit (Sandy Acres Pit) is located approximately 1.5 mile northeast of Henderson, Colorado.

The site is current inactive. The last annual report indicates the site has not been operational since 1998-1999. The pond slopes are stable and well vegetated with a variety of grasses. The Division cited a problem in the March 2, 2011 inspection report for failure to protect the hydrologic balance as required by Rule 3.1.6. The Operator shall demonstrate in AM-06 how the Operator intends to comply with Rule 3.1.6.

The Operator submitted AM-06 to expand the permit boundary and change the post-mining land use. The Operator has proposed changing the post-mining land use from a pond/residential to pastureland. The proposed plan would allow the Operator to run a box culvert underneath a portion of E-470. The box culvert would contain a conveyor belt allowing the operator of the adjoining gravel pit (Pit 29, DRMS permit No. M-1980-183) to transport wash fines underneath E-470 into the Henderson Development pit. The Division understands that the Operator will use the wash fines to backfill the Henderson Development pit to midigate the exposed groundwater liability.
