Dear Moffat County Commissioners:

The Division of Reclamation, Mining and Safety hereby issues notice, in accordance with Title 34, Article 33, Section 116, Paragraph 4, of the Colorado Revised Statutes, that on April 2, 2014 an application to revise coal mining operations at the Colowyo Coal Mine was considered complete for the purposes of filing. The revision was submitted by Colowyo Coal Company L.P.. All review and comment periods as provided in the Act and the Regulations initiate from this date of filing.

TR-102 revises the design for the lower portion of the West Pit Coal Road Ditch, changing the design from trapezoidal to triangular.

The Surface coal mining operation is on land located approximately 28 miles South of Craig, Colorado. The permit area is further described as follows:

All or portions of Sections 2, 3, 4, 8, 9, 10, 11, 14, 15, 16, 17, 20, 21 and T3N, R93W; and Sections 13, 15, 22, 23, 24, 26, 27, 28, 33 and 34, T4N, R93W; 6th Prime Meridian.

The above-mentioned tracts of land are shown on the following USGS 7.5 minute Quadrangle map(s): Abarr.

The applicant is required to publish notice in a local newspaper that this application has been deemed complete. At the time of publication of this notice, the applicant is additionally required to place a copy of this application at the Rio Blanco County Clerk and Recorder, P.O. Box 1067, Meeker, CO 81641; Moffat County Clerk and Recorder, 221 W Victory Way, Craig, CO 81625, and at the Division office. In order for us to comply with regulatory time frames, we request that comments be submitted within fifteen (15) days of this letter. If no comments are
