Mr. Mushinski:

On April 12, 2013 the Division of Reclamation, Mining and Safety granted limited (partial) approval of Amendment AM-04. Attachment A to this letter identifies the documents that were approved in the partial approval. As specified in those documents, the partial approval permits pumping of water from the underground workings, treatment of the pumped water using ex-situ and in-situ methods, and disposal of backfill slurry into the mine workings. Cotter Corporation consented to the limited approval in their letter to the Division dated April 12, 2013.

The materials approved in the partial approval are hereby incorporated into Permit No. M-1977-300. All other conditions and requirements of Permit No. M-1977-300 remain in full force and effect.

The required additional financial warranty associated with the partial approval of AM-04 has been determined to be \$1,417,309. Please be advised that you may not commence operations covered by the partial approval of AM-04 until the additional financial warranty has been submitted and accepted by our office. You will be notified in writing when it is accepted.

The Division continues to review AM-04 materials that were submitted but were not approved in the partial approval. The Division anticipates issuing a decision regarding those materials by May 1, 2013.

Supplemental Mine Pool Monitoring Plan

This monitoring plan supplements Cotter's existing quarterly full-suite sampling of the mine pool.

Commencement of supplemental plan: Upon commencement of mine pool pumping.

Sampling frequency: Bi-weekly (once every two weeks) for first 6 months, then monthly for 18 months or longer if required by DRMS.

Reporting of analytical results to DRMS: Within 30 days of the day a sample is collected.
